

### **LEARNING TRADITIONAL HEALING**

Jack Chambers, Jr. of the Grand Traverse Band visited the Pokagon Band last month. The Pokagon Band Health Department and Education Department teamed up to bring Chambers to teach our members about the use of nature's gifts for healing.

Although the discussion was about traditional medicine, Chambers gave a history lesson as well. He talked about our people being very healthy until the whites brought their diseases over to this land.

Chambers said, "We were the healthiest people in the world and in our world there was no disease of smallpox."

He also pointed out that our immune systems

were not equipped to handle these diseases and it often proved disastrous for Native peoples.

Chambers spoke of the environment and its effect on our overall health. The concern is too often saving money versus using products less harmful to the environment.

The attendance was high at this event. People listened intently to as he spoke of helping Native Americans to live healthier lives. His talk was followed by a question and answer session. There was also an evening session for people who wanted to attend after work.

## POKAGON HEALTH SERVICES

## Contract Health Staff works steadily to complete all 1997 accounts

In 1997, 2,000 Contract Health Services vouchers were generated on behalf of more than 700 unduplicated clients who, in turn, saw in excess of 200 separate health care providers.

It is gratifying to reflect on the amount and variety of health services that was delivered to our families in the past 12 months through contract health. On the other hand, dealing with 200 separate billing systems is slow and complicated A bill goes through many steps and people before a payment gets credited to an account. This means delays. If you or another Band member you know is experiencing frustration with a prior-approved 1997 CHS encounter, please call for yourself or urge other members to call Lois Wesaw, CHS Benefits Specialist. This office can help or fix something only if we know what to fix.

## What the heck is an EOB? And other contract Health Service questions.

If you call Lois about a bill or bills, depending upon the situation, she may ask you to bring in all your medical bills plus any and all correspondence from your insurance company. She will most likely ask you for the EOB'S. The EOB is the Explanation of Benefits provided to you by the insurance company as required by law. The EOB states the date of service, who the provider was, how much the provider charged for the services rendered, how much the insurance company paid and what is left due outstanding to be paid to the provider. (On the EOB, the outstanding amount due usually is highlighted by the words "you pay this amount". As the payor of last resort, this is the amount that CHS will consider paying.)

## Not all correspondence from the insurance company is junk mail:

If your insurance company pays you a check directly for any of your claims, it is your responsibility to make a payment yourself to your provider in the amount the insurance company has paid you.

Despite our requests, a few of the 200 providers our members use just won't bill out to a secondary payor: If you are receiving bills at home, assume that the billing company or the provider is not sending your

bills to our contract health service office. Therefore our office is unaware that the billing has progressed to the point that payment is expected or due.

A late March health fair is in the planning stages to benefit the Pokagon Band. Details are being worked out for this fair between Pokagon Band staff, Lee Memorial and Cass County Department of Public Health. The program will feature community health events and will have more events focused on men's health issues than previously. In response to requests, lab tests for chemical profiles, blood glucose, and cholesterol will be offered. Details will be announced in upcoming newsletters and flyers.

#### Twin Cities Optical Program Taking Shape

Susan Beavers and Trish Williams are receiving training in Traverse City at the Twin Cities Optical factory so that they can become dispensers of eyewear through our Pokagon Band Health Services Eventually, following their training, members will be able to bring in an optometrist's or opthamologist's prescription for glasses to Susan or Trish. Susan or Trish will be able to help our clients choose a frame from among the 150-frame selection we have on hand. Susan or Trish will order the eyewear which the member can then pick up in about four days. More details about this program will follow in the coming weeks.

Limited transportation, on a last resort basis, is available Mon.-Fri. for health care appointments scheduled between 9:00 a.m. to 3:00 p.m.. Please call the Health Office at least 72 hours in advance of your scheduled appointment.

## **POKAGON HUMAN SERVICES**

#### **Attention Pokagon Band Members**

Repair and renovation (R&R) department has finally received some funding for the next year. This funding is Housing and Urban Development (HUD) and the income guidelines differ from Housing Improvement Program (HIP) guidelines. The income guides are based on the median income in each of the ten counties in our service area and is for low to moderate income. The HIP is based on the federal guidelines, so each county will have different income limits, and the income level is higher than the HIP program. The policy guidelines will be the same except for income qualifications. If your income is below the level for HUD funding, you will be put in the HIP program. If your income is above the moderate level, you will be put on a waiting list in case of a different type of funding. Each qualified member will receive \$20,000 on their home total. When this is reached, you no longer qualify for repairs.

It can only be spent on one home. If you start on your home and move to another, you can't receive R&R on the next home. You cannot qualify for both programs. If you sell your home within five years of completion of R&R, you will have to repay any amount spent on your home to the Pokagon band.

The cap of \$20,000 doesn't mean you will receive it at one time. I will do the most urgent thing on the list first. This funding has to be spread out among as many members as it can. Each member can only turn in one application, so make sure you put everything on the application the first time.

I will send the application out to the member. If a member qualifies, I will visit the home and make a list of things you want done and prioritize according to urgency of need. I will send the list to the contractors I have on my list. The contractors will have ten working days to bid and send it back to me. Once received, I will take the three lowest bids to the elders committee for review and they will pick a contractor. If the home owner has a preferred contractor, that contractor can also bid on the job. I will send them a bid sheet. Their bid will be given the same consideration as any other contractor. However, the final decision rests with the elders committee!

The selected contractor must set a start and finish date. They will be expected to get started and finished by those dates (weather will be considered). Fi-

nal payment won't be made on any job until the contractor and myself do final inspection and everybody is satisfied. Again, I will do the most urgent needed thing on your list first and then review the list later in the year for other repairs.

I am reviewing all applications that have qualified for one of the programs. I will put each member in the right program and will be contacting you to set up a time to come to your home to start the process.

The funding for the HIP program is not at a level to maintain full services. The amount that can be spent on homes is limited. This program won't be fully funded until October, so members in this program must be patient.

The sanitation program is there for anyone whose well or septic is failing. If you are building a new home in the ten county service area, you qualify for service. **This program runs on a first come first serve** basis, so call if you need an application.

The **Down Payment Assistance Program** is for those members who can secure a mortgage at a bank or mortgage company or land contract. For any of these programs, you must live in the ten county service area. Any questions about any of these programs please call me at 800-517-0777







#### SECRETARY ISSUES PRELIMINARY RULES

Since the 1996 Seminole decision, Indian gaming across the country has been at a standstill for tribes who are trying to begin an operation. The Pokagon Band is in this category and until January 16th, there was no way to resolve the problem. There was good news out of Washington, D.C. when the Department of Interior announced that it has concluded it has the authority to prescribe procedures permitting Class III gaming to an Indian tribe in a situation where the state has negotiated in "bad faith" by asserting sovereign immunity. The Indian Gaming Regulatory Act (IGRA), enacted in 1988 requires states and tribes to negotiate in good faith in reaching a compact agreement.

The rules proposed today have a direct impact on the Pokagon Band of Potawatomi Indians, particularly in the state of Michigan. The tribe filed the lawsuit in July, 1996 against the state of Michigan. This suit was dismissed when Michigan asserted its sovereign immunity, following a April, 1996 Seminole decision that allowed states to raise their Eleventh Amendment defense against lawsuits brought by tribes alleging bad faith. When these rules take effect, an Eleventh Amendment defense will trigger action by the Secretary of the Interior.

Tribal Chairman Robert Moody says, "We are pleased and view this as an opportunity for the tribe and the state to come together and work through compact negotiations. We've always maintained that the Secretary of the Interior and the federal government would recognize its authority and responsibility and take a pro-active role on behalf of Indian tribes.

"The Seminole decision simply took a remedy out of the 1988 Indian Gaming Regulatory Act. It never changed the fact that states had to negotiate with Indian tribes in good faith. These rules simply offer a solution for tribes that have reached an impasse with their state.

"Should the Secretary step in to prescribe a compact, the tribe will no longer be bound by the existing compact signed by Governor Engler that the Legislature has failed to pass. The state then runs the risk of being completely taken out of the process."

While the process may take time, it is the first positive step the Interior has taken publicly since the Seminole decision. The tribe now has another avenue should the Michigan legislature choose to continue stalling.
