He has a very large and important task—for to reach a goal, you must have a plan. If you happen to reach a goal without a plan, it is purely by accident and you should feel extremely lucky. This grant does not have to be paid back and is a one time only assistance. There are eligibility requirements for each type of loan and the grant assistance. I have applications you can fill out and send into the USDA to see if you qualify. The income guidelines are from 80% of the median income and below for the area in which you live. 





Many, many moons ago, there lived an old man alone in his lodge beside a stream in the thick woods. He was heavily clad in furs, for it was winter, and all the world was covered with snow and ice. The winds swept through the woods; searching every bush and tree for birds to chill, and chasing evil spirits over the hills, through tangled swamps, and valleys deep. The old man went about, and peered vainly in the deep snow for pieces of wood to sustain the fire in his lodge. Sitting down by the last dying amber's, he cried to Kigi Manito Waw-Kwi (The God of Heaven) that he might not perish. The winds howled. and blew aside the door of his lodge, when in came a most beautiful maiden. Her cheeks were like roses; her eyes were large, and glowed like the fawn's in the moonlight; her hair was long and black as the raven's plumes, and touched the ground as she walked; her hands were covered with willow-buds; on her head were wreaths of wild flowers, her clothing was sweet grass and ferns, her moccasins were fair white lilies; and, when she breathed, the air of the lodge became warm and fragrant.

The old man said, "My daughter, I am glad to see you. My lodge is cold and cheerless; yet it will shield you from the tempest. But tell me who you are, that you should come to my lodge in such clothing. Come, sit down here, and tell of thy country and thy victories, and I will tell thee of my exploits. For I am Manito."

He then filled two pipes with tobacco that they may smoke together as they talk. When the smoke had warmed the old man's tongue, again he said, "I am Manito. I blow my breath, and the lakes and streams become flint." The maiden made answered. "I breathe. and flowers spring up on all the plains." The old man replied, "I breathe, and the snow covers all the earth..... I shake my tresses," returned the maiden, "and warm rains fall from the clouds." "When I walk about," answered the old man, "leaves wither and fall from the trees. At my command the animals hide themselves in the ground, and fowls forsake the waters and fly away. Again I say, I am Manito." The maiden made answer, "When I walk about, plants lift up their heads, and the naked trees robe themselves in living green; the birds come back and all who see me sing for joy. Music is everywhere."

As they talked, the air became warmer and more fragrant in the lodge and the old man's head drooped upon his breast, and he slept. Then the sun came back, and the blue birds came to the top of the lodge and sang. "We are thirsty." Sebin (The river) replied, "I am free, come and drink." While the old man was sleeping, the maiden passed her hand over his head, and he began to grow small. Streams of water poured out of his mouth; very soon he became a small mass upon the ground; and his clothing turned to withered leaves.

Then the maiden kneeled upon the ground; took from her bosom the most precious pink and white flowers, and hiding them under the faded leaves, and breathing upon them said, "I give you all my virtues, and all the sweetness of my breath, and all who would pick thee shall do so on bended knees." Then the maiden moved away through the woods and over the plains; all the birds sang to her everywhere she stepped, and nowhere else grows our tribal flower—the Trailing Arbutus.



The Grav Wolf Clan

Many, Many moons ago there was a clan of wolves. This clan was the fiercest hunters of all wolf clans in the world. They were strong because they were one body of the same animal. They shared a strain of genetics that allowed them to have the best of both worlds. They were a combination of the Black Wolf and the White Wolf Clan. He said that trouble had come to teach us how to live, and be one together. That divisions based on color of coat was a foolish and dangerous thing, because underneath we are all wolves, and are a Part of the Great Manitou. He said that if we were ever to divide again, it would mean our total destruction. It must never happen again."

The old ones nodded and offered meat to the ancients and began their long journey back to their own divided clans. The old ones awoke in their den and set out to call a council with the leaders of the three camps. The Gray wolf who was the oldest decided that he would stay within the cave womb of the earth mother to welcome all of his stubborn grandsons. The White Wolf, and the Black Wolf elders both agreed because he was the Grandfather of them as well, and it was their responsibility to gather their Children to council.

"I will tell you again," said Grandfather as he smiled at his sons. "Our brother, the White buffalo, brings us many gifts, but his greatest medicine is the give away or the thanksgiving medicine. He teaches us to be grateful for the many things that the Creator and the Earth Mother freely give to us."

feast with him. They all sat quietly and thought about how their brother, the White buffalo had given himself to their Grandfather that day to save them and their families.
