

#### **Contract Health Services**

If you are experiencing slow payments to your providers for your CHS accounts, give Lois Wesaw, Pam Mersereau or Christine Daugherty a phone call at (616) 782-4141 or (888) 440-1234. If after business hours, you can leave a message on our answering machine and someone will return your call as soon as we are able.

IF you are receiving bills at your home, our office most likely is not receiving those bills. We have asked the providers to send the bills directly to our office, but too often this does not happen. Send your bills into our office or bring them in yourself so that we can process these for you. Without the bills or your insurance (if you have insurance) Explanation of Benefits forms we cannot process payments for you, so send these in or bring these in as soon as you get them. We want to pay your pre-approved CHS accounts.

## Contract Health Services and Tribal Enrollment Cards

Enrollment cards are being sent to members through the mail! On your enrollment card you will read the notice: This member may be eligible for Contract Health Services. Call 1-888-440-1234 for verification. This notice is intended to help our CHS eligible clients when they access pre-approved CHS health services. Or in cases of extreme emergency care. The enrollment card does not automatically signify that a client is enrolled or eligible for CHS, members still must be entered into the Patient Registration system, must live within the 10-county Contract Health Service Delivery Area, and must seek prior approval through our office for each health care visit to receive CHS benefits. Call our office for more details.

## Commodity Food Distribution Program (FDP):

Our FDP underwent a technical assistance visit on February 11-13 by the USDA Food and Nutrition Service. It consisted of a review of our inventory management, warehousing, computer training, and an inspection of files (random five) to examine household application and certification procedure. The third day concluded with an exit conference to discuss the evaluation findings. Overall, it was a positive review but deficiencies were located in several areas of the certification/eligibility process. We must now respond with corrective action and expect a follow up visit by the USDA Food and Nutrition Service to review the action taken.

Staff are working diligently to make these corrections and need cooperation from the participants to do so. Participants will receive notification by mail indicating when it is time for renewal. To expedite this process, please bring the required documents for proof of income and/or other verification to update your case.

Another area of concern is dual participation. Dual participation in the Pokagon Band Commodity Food Distribution Program and Food Stamp Program is illegal and subject to possible fraud charges and/or losing benefits of both programs until the matter is resolved. This information is written on the application, posted in the food commodities building and staff verbally reminds participants. As a preventive measure, we are required to cross-check participants with the Family Independence Agency and unfortunately as a result, some participants have been disqualified from the program.

As you can see, the program underwent an indepth review. Food Commodities staff and the Social Services Director are working to serve the needs of tribal members as well as satisfy regulations of the USDA. The USDA is the major funding source of this program and our compliance with these regulations is essential for future funding.

To improve accessibility, we are also reviewing the Commodity Food Distribution Program building hours to determine the need to adjust the schedule to better suit your needs. Current schedule: Monday - Friday 8am - 5pm Saturday 8am - 12:30pm Sunday Closed

If you have any questions about your certification or need to make special arrangements to pick up your commodities, please contact John Miller, FDP Site Supervisor at 888-281-1111. I welcome your suggestions for improving our food commodities program and can be reached at 800-517-0777.

#### Notice of changes to Emergency Funds:

- 1. As of March 2, 1998, all applications for emergency funds will be taken to the Emergency Fund Committee meetings on Mondays at 10am. No determinations will be made by phone except for requests for funeral assistance. This will improve the review process by allowing committee members time to consider all information submitted with the request.
- 2. As of November 20, 1997, Tribal Council passed a resolution to "remove the Low Income Home Energy Assistance Program (LIHEAP) from the Emergency Fund Program and let it stand alone." Since that time, all energy assistance is provided through LIHEAP. Eligibility is based on income, and the participant is responsible for providing proof of 30-day income and vendor information to qualify for assistance.
- 3. As of October 1, 1997, the Emergency Fund Program is only available to enrolled Pokagon Band members located within the 10 county service area. At that time, there was a change in funding from the general fund to '638 monies' (federal fund); therefore, federal guidelines apply, which limits eligibility to the service area.

On Monday, March 23, I was told by Gerald Parish from the Bureau of Indian Affairs (BIA) that, on April 1, 1998, the Down Payment Assistance Program will no longer be funded by the BIA. This came as a big shock to me because there was no mention of it in the new Rules and Regulations published on March 2. It is because of the revisions to the rules and procedures governing the Housing Improvement Program that the Down Payment Assistance program was canceled. So until further notice this program is officially closed.

I am also trying to start up a credit counseling seminar once a week, either at the administration building or at the elders hall. This would be a great time to start to get all of your questions answered about what needs to be done to clear up your credit history. This is the number one problem most of us have when it comes to buying a home. So if you think you would like to attend, call and let me know. This will also benefit anyone who might want to buy a home on the reservation when we start to put up housing. It is a chance to clean up your credit and learn to manage your money, so your dream of owning your own home will come true. So call me at 800-517-0777 and let me know if you're interested in this program.

# FIRST TIME HOME BUYERS SEMINAR


Keith White (HIP Coordinator) set up a seminar for people interested in buying a home, and not sure where to start the process.

Four people from different agencies explained various programs that help low to moderate income leveled families obtain homes. If people do not qualify for those programs, there was advice on how to qualify for commercial loans.


The advice ranged from various agencies that could help to the cleaning up of credit records. The presenters stressed the importance of a solid credit rating when anyone goes to buy a home.

Some of the presentations addressed the hidden problems or pitfalls that first time home buyers go through. There are hidden costs along with issues many people don't associate with owning a home. The presenters offered assistance or recommended some information people should gather before they even start searching for a new home.

#### **Scholarship Program - Summer Sessions**

The Bureau of Indian Affairs requires us to have a separate application for summer college sessions. Application packets have been developed and are now available by calling the Education Department at 616-782-0887 or 1-888-330-1234. Please leave your name and address with Lucinda, and we will mail you the application materials. Funds are available for part-time and full-time summer attendance.

**Reminder** - Students seeking financial aid for Spring and/or summer sessions must complete 1997-98 FAFSA (Free Application for Federal Student Aid) if they have not done so already.

#### Scholarship Program for 1998-1999 Award Year

The FAFSA (Free Application for Federal Student Aid) is now available at the financial aid office of colleges and universities. You will use your 1997 Federal 1040 to complete your FAFSA for 1998-99. If you are a dependent student as defined by federal regulations, you will also need to use your parent's Federal 1040. Make photocopies of these documents before mailing the originals. If selected for verification, you may need to bring copies to your college's financial aid office. All students must apply for FAFSA prior to applying for the Pokagon Band Scholarship.

Vocational Scholarships Available The Tribe funds student participation in accred-

ited vocational programs and/or courses. For example: we have funded a computer repair program, beautician training, and paralegal courses. It is a great opportunity to obtain marketable job skills without attending a traditional college. Students must apply for the institute's available financial aid before applying for the Pokagon scholarship. The tribal scholarship will cover unmet financial need up to \$1000.00. Continued funding is based on satisfactory progress as well as unmet need.



These sources will identify scholarships based upon your personal characteristics such as academic standing, enrollment plans, colleges, major, career goals, memberships in clubs, etc. They can be accessed at www.finaid.org. You should search at least three of the five databases as information is not always duplicated: FastWEB, CollegeNET MACH 25, ExPAN Scholarship Search (FUND FINDER), SRN Express, and Sallie Mae/CASHE (College Aid Sources for Higher Education). These searches merely identify potential scholarship sources. You must write to each source to request application materials.






