COLUMBUS DAY; NO CELEBRATION!

Vernon Bellecourt, an Indian activist, lead a protest in front of Congressman Tim Roemer's office in downtown South Bend.

Bellecourt was visiting the Notre Dame campus on Monday, October 12, for a multicultural awareness program on Columbus Day. Bellecourt is a long time Indian activist, and he has been involved with the American Indian Movement for many years.

Bellecourt and his group research areas before they arrive. He said they were appalled at what they found in the newspapers.

Despite the fact that Congressman Roemer was instrumental in the Pokagon's federal restoration, he has sinced waged a battle to keep the tribe from pursuing its rights under the federal law.

Bellecourt burned an effigy of Columbus in front of Roemer's local office, which ironically was closed to celebrate the Columbus holiday.

Bellecourt spoke at Notre Dame about what Indians and other minorities face. He talked about the colo-

nization of Indians. He reminded the crowd that Indians functioned quite well before Columbus "discovered" America.

Bellecourt also talked about the Pokagon Band and the institutional racism we face in Indiana. It comes from many areas. He included some of the church groups that have fought the tribe. Unfortunately, they can hide behind their concerns over gambling.

Bellecourt reminded listeners that when opponents fight tribes on gambling, they are also fighting the abilities to get land. Land is very important so we can build a stronger community.



COUNCIL CORNER

This is the first in a series of articles from individual council members to our membership. I am grateful for the opportunity to be the first in this series. As most of you know, I have been given the privilege to serve not only as the treasurer for the Band, but also its finance director. Much of my focus has been directed towards pursuing the Band's opportunity to establish casinos in both Michigan and Indiana. I've also been reviewing other business opportunities that are presented to the Band. Until recently, there hasn't been anything new to report.

On the casino front, the council has voted to terminate the Band's development and

management contract with Harrah's. Circumstances dictated it was in the Band's best interest to move in a different direction with a new developer and manager. Much has been learned about the business of gaming which should prove to be to our advantage in future negotiations with a new developer/manager. I am confident we will not miss a beat once a new deal is negotiated. There have been a number of inquiries from interested parties to become involved with our project(s). Especially in light of recent news on the Michigan compact. Currently, there exists a real desire on the part of politicians to address our compact. There is a whole multitude of political reasons as to why this is happening. The most significant of 'which is protecting the progress Detroit has made in accomplishing their casino goals. We are cautiously optimistic that the political leaders in the state will live up to their recent commitments to approve our compact. Keep an eye on the activity in the state legislature after the November elections. If it is to happen politically, it should happen before the end of the year.

Members of our community development and housing staffs, along with myself have investigated business opportunities in the commercial housing and injection molded plastics industry to determine their viability as a Band business. Discussions, along with proper due diligence, are ongoing to make sure these opportunities benefit the Band and its members.

We will continue to investigate any potential opportunity presented to the Band for consideration.

Not all of the council's efforts have been devoted to Casino and business ventures. We have been dealing with the increased opportunities to expand services to members through our health, housing, education and social services departments. Each respective department head -along with the community development department has been exploring potential new services which can be offered to membership.

Each of you can take a role this process by letting council and staff know what you need in the way of services. This can be done either through letters or phone calls. The most effective way may be to join a committee in an area of particular interest. Hopefully, we can address those areas which can serve you best.


POKAGONS BUY LAND

The Pokagon Band has purchased more than 300 acres of land near Dowagiac. It is northeast of Dowagiac on Gage St. The property, for those familiar with Dowagiac, is the old Holloway property. It is a perfect piece of land to start the anchor point in the Dowagiac

It is a beautiful piece of land, that includes a lake on its premises. The land committee had put in a great deal of work on the acquisition of this property. As the tribe attempts to build its land base, it becomes more important than ever to get land.

There is speculation that we purchased this land for a casino. The final say on land usage belongs to Tribal Council, however it is important to remember the tribe has many other needs aside from the casino. It is more likely that the tribe wants to use this site to start its reservation for housing, government offices and/or a health clinic or school. Those are just some of the potential uses.

Nothing has been decided upon, and the land committee will continue to work to find more land that fits the needs of the tribe. We will be planning an open house for members to see the land for themselves. Please watch your mail for dates and times. FLU SHOTS

The time is now to get your flu shots. The shots are available at the Health Office at no cost to Tribal Members.

Why do I need a flu shot every year?

They change both gradually and abruptly, and each change may enable the virus to skirt around your hardwon immunity from a previous viral bout, invade your respiratory tract and cause the flu. This genetic instability is why people get influenza over and over again, why they get it some years and not others. This is why some atttacks make them much sicker, and why it's necessary to get a new flu shot every year for maximum protection.

Who should be immunized?

Anyone over six months old with cancer or an immunosuppressed disorder (including HIV) or those on medications that suppress immunity and lower the body's resistance to infection.

Child or adult with chronic heart or lung disease, cystic fibrosis, diabetes, kidney disease, anemia or severe asthma

Kids between six months and 18 yrs. old who are on long-term aspirin therapy.

Anyone 65 or over.

Residents of nursing homes and chronic care facilities.

CPR Community First Aid

The Pokagon Band will soon be offering CPR and first aid classes for people interested in certification. The content of the five basic level courses provides consistent guidelines that enable a person to give appropriate care, regardless of the emergency. It begins with the most important decision to act and help participants confront their fear of stepping forward to assist

Among the things this course teaches is the ability to recognize and care for respiratory and cardiac emergencies (rescue breathing, clearing an obstruction, CPR). Please call Mark Topash at the Health Office.

POKAGON HEALTH NEWS

BASIC CONTRACT HEALTH INFORMATION

For Contract Health Services to make payments on your behalf for your health care services you must:

- 1. Be a Pokagon Band member.
- 2. Live within the Contract Health Service Delivery Area.
- 3. Register for Contract Health Service benefits. This includes providing our office proof of your insurance or if you have no insurance, you must provide to this office a copy of the denial letter from your local Family Independence Agency. You will be asked to update your file once every 12 months and on an ongoing basis as you make requests.
- 4. Seek prior authorization at least three working days before scheduled health care appointments. You must request CHS coverage before you go to your appointments. Seek separate authorizations for all follow-up appointments, treatment plan follow-up dates, plus any and all labs. CHS cannot pay for health care services without prior authorization.
- 5. Seek authorization within 72 hours of the start of emergency or urgent care. Elders or disabled clients have 30 days to notify our office in case of emergency care.
- 6. Get copies of provider bills to our office. Without the bills, payments cannot be processed.
- 7. IF you have health care insurance(s), you must provide copies of your insurance Explanations of Benefits (EOBS) to our CHS staff. The EOB is the paper from the insurance company, which explains what they have paid and the unpaid balance. Without an EOB, payment will not be processed.

We have Contract Health Services staff people available to assist you. Please call with your questions.

WHERE ARE THE CHILDREN GOING?

About 25 people heard an alarming fact about the Pokagon Band on Wednesday, October 21. Only one Pokagon family is licensed to host a foster child.

There have been several cases of removal in Pokagon families, and the small amount of foster care homes makes it difficult to keep Indian children with Indian families.

The Pokagon Band Social Services Department hosted a seminar about the Indian Child Welfare Act and its effect on tribal children. An attorney with Michigan Indian Legal Services spoke about what her services could do for members and the types of situations they can help resolve.

The Social Services staff continues to work hard at educating the Michiana area Family Independence Agencies about ICWA and what rights Indian parents and children have.

The second half of the program involved the licensing process for potential foster parents. Two MICWA workers explained the process and procedures that members would face if they wanted to become involved. They handed out packets and went through many different scenarios and ways members could become license. There was some real interest from some members in attendance. That is good news for our Social Services Department as they try to find different ways to keep Indian families together.

Gerald asked Tom Russell to introduce himself. He stated he is from Arkansas and visiting with the Tribe for the month of September. He will be working with David Alexis primarily on strategic planning.

Gerald stated that the by-laws have been approved by the popular vote of the Membership. So we will not be violating our by-laws; the Officers will be approving the minutes and resolutions; unless it calls for a popular vote.

Gerald introduced Rechelle Herman as our temporary Coordinator. Rechelle is a Social Service outreach staff

Copies of Gerald's annual report were available for everyone.

Clarence gave his updated budget report.

An amendment was made to our Elders Council Ordinance by Marchell Wesaw.

Resolution #98-024, dated August 31, 1998, sponsored by Mary Church, seconded by Marge Moody.

NOW, THEREFORE BE IT RESOLVED: That the Elders Council propose the following addition to the Elders Ordinance: The Elders Council may, without further approval or ratification from Tribal Council, appoint or otherwise select delegates, committee members, or other such representatives to national, state or local organizations promoting Elders affairs. If the Elders Council decides it necessary, the Elders Council may deem the selection of these representatives an "election" for purposes of Section 4 of the Elders Council Ordinance. This provision is to be incorporated into the Elders Council Ordinance.

Marge Moody contacted the MIEA Secretary Mary Antilla and submitted the changes for the MIEA By-Laws. Nominations will be taken at the October 1st business meeting for two (2) Delegates and one (1) Alternate.

The Prophetstown trip on September 21st is sponsored by the Education Department. John Warren, Cultural Coordinator was not able to attend this meeting; so Clarence gave us some details of the trip. Elders will meet behind the Education Department at 8:00 A.M. Clarence thanked Mary Church for all the work she did at-the Huron Potawatomi Gathering. He also thanked the Elders who helped her. There was also a discussion with membership about the Gathering.

Gerald introduced our Housing Director, Jesse Howell. Tribal Council has directed Jesse to do a survey on housing. He needs input from Elders which way to go with housing rules; what Elders want. There is a need for an Elder to be on the Housing Committee.

Linda Mangus, Social Services Director was here to explain some of the services under this program. Programs being: JPTA, LIHEAP, EMERGENCY, INJURY PREVENTION, and COMMODITIES. She also works with the IHS staff and the MICWA Agency. Linda stated that they will be filling the Elders Coordinator position this fall.

LIHEAP NOTICE



Neshnabémwen: Potawatomi Language Project

The Mission of this project is the preservation and promotion of the Potawatomi language. It sounds simple, until you think about how to do it. Let's look at it


Preservation: Webster defines preservation as protecting against injury or peril, or to maintain unchanged. How do we preserve our language? How can we protect a language from injury or peril? How can we maintain a language? From this definition, we have three topics to cover.

Injury: We injure a language when we argue over the "proper" way to spell it. We injure a language when we dispute the appropriateness of a reference. We injure a language when we argue over the amount of money a speaker receives for their cooperation. The only way the Potawatomi language will survive these injuries is by working together; like the old saying goes; don't point a finger, lend a hand.

Peril: The peril the Potawatomi language faces is extinction. When a language is not taught to children, as their first language, it is considered *Moribund*. A word literally meaning 'bound to die'. Our dialect has faced this for two generations. We can change it by teaching our children what we know, and learning wherever we can.

Maintain: We maintain a language by speaking it and encouraging (promoting) others to also speak that language. That is what we're working towards.

Currently, the language program is working with cooperative elders, specifically, Martin Wesaw and Mae Wesaw. We're developing our speaking skills and developing materials to use in our upcoming head start program. Speaking Potawatomi in the future requires the language program has to start with the children. We will have materials for all ages, but that takes time. Although materials we're developing are intended for children, they are informative. If we remember the child within us, they can be interesting as well. The materials are available to any member. Just contact Frank Barker or John Fox at the Education Department.
