Hello everyone,

Many wonderful things have been happening to our tribe in the last few months. This is a historic time for the Pokagon Band. It is my honor to be able to share our accomplishments with you, and I hope all of you share my pride in what has been accomplished in a short amount of time.



Gaming site

We have submitted our application to the Bureau of Indian Affairs (BIA) to take our gaming parcel in New Buffalo into trust. Included with the application was the local agreement signed by the city and township of New Buffalo. This document expressing their support for our gaming project will do much to expedite our application. Resolutions to support our efforts have also been passed by Chikaming Township, Three Oaks Township, and the villages of Three Oaks, Grand Beach, and Michiana.

We have finished the 30-day comment period, which allows citizens and tribal members to write to the BIA regarding the casino. I also traveled to Minnesota during June to meet with the BIA regarding our application. The following are the next steps in our application process:

- The BIA will form its recommendation and share it in letters to state and local officials. The public is entitled to request a copy of the letter and may appeal the BIA's recommendation, or ask the BIA to reconsider.
- Once any appeals are decided, a title search will be completed on the property included in the application.
- A legal notice will be published in the newspaper, and anyone has 30 days to appeal the recommendation.
- The BIA sends the recommendation to the Secretary of the Interior, who makes the final decision.

Barring appeals or complications, we hope to have the land in trust by the end of the year, and the casino open by fall 2001. When we have approval on our application, we will better be able to give you dates on events such as construction, hiring, and the grand opening.

Gaming compact

I'm sure many of you know that our gaming compact was one of four compacts ruled invalid by Ingham County Circuit Judge Peter Houk. Judge Houk ruled that the Michigan Legislature cannot approve the compacts through resolution; it must be done by legislation. Legislation would need a majority of the members serving in the Legislature (56 of all 110 votes). A resolution only needs a rr ajority of the members present at the time of the vote.

The compacts were deemed approved Feb. 2, 1999, and published in the Federal Register on Feb. 18, 1999. The BIA is still processing our application, and the state is still accepting money from other casinos that

also had their compact ruled invalid. These are sure signs that the state and federal governments do consider our compact valid. The lawsuit is, however, in appeal, and is expected to head to the state Supreme Court.

Gaming contracts

Our gaming contract with Lakes Gaming, Inc. has been sent to the National Indian Gaming Commission (NIGC) and is waiting for review. It will be evaluated simultaneously with our application to take the gaming parcel into trust.

Reservation sites

We are continuing to secure the three reservation sites promised to us in Memorandum of Understanding signed last January. The agreement allows us to take up to 4,700 acres of land into trust in our traditional homelands. Roughly 700 acres have already been sited in New Buffalo for our casino operation. The remaining 4,000 acres will be used for tribal housing, offices, recreational facilities, and preservation land for the benefit of our future generations.

We have secured options on reservation sites in Hartford and Dowagiac, Mich., and are currently identifying possible sites near Indiana's St. Joseph River Valley. It is important that we keep the specific sites quiet during the process as not to drive up land prices. We will let the tribe know the exact locations as soon as we are able.

We are in the planning stages of many other projects. Staff and tribal members are working on ways to better unify the tribe, as well as supply much-needed resources. With the membership spread among Michigan, Indiana and throughout the country, it is important that we take extra steps to make sure that all of our members are receiving what they need.

I want to thank everyone for all of their hard work. The Tribal Council spends many nights each week making wise decisions on what is in the best interest of our tribe. The Elder's Council performs their governmental duties and provides me with much-needed advice. The committees are vital in providing the planning and details for many of our projects. Your hard work does not go unnoticed or unappreciated.

It is also important that we remember our ancestors, who paved the way for the wonderful things happening to us. Without their hard work and dedication, we would not be here today.

Application terms

With all the new experiences happening to the tribe, it sometimes can be tough to keep ahead on the new terminology. Here are a couple phrases that you might have heard being used.

What does "fee-to-trust" mean?

The fee-to-trust process is our application to the Bureau of Indian Affairs to designate certain land as reservation land. This is also called putting land into trust. What actually happens is the federal government takes the land off the role books, so it no longer has taxes paid on it. Instead, it is reservation land owned by the band.

Some people do get angry over land that is no longer having taxes paid on it, however the local governments are not losing money on the deal. Our gaming compact with the state ensures that a percentage of slot machine revenue be given to the state and local governments. The state

receives 8 percent, and the local governments share 2 percent. Our Local Agreement also provided money for the reservation lands in Hartford and Dowagiac, Mich., and near Indiana's St. Joseph River Valley that will be taken into trust.

What is the difference between the BIA and the Department of the Interior? The Bureau of Indian Affairs (BIA) is a division of the Department of the Interior. The Department of the Interior handles all matters regarding Native American land and all American-owned property, such as national parks. The BIA is responsible for handling Native American concerns and issues.

In the case of our application to put land into trust, the BIA will make a recommendation to the Department of Interior, and the Department of Interior will make the final decision.

Strategic Planning Committee

A Strategic Planning Committee has been formed to help the Tribal Council and staff target and effectively respond to the needs of the members. You will recall the committee conducted a survey back in summer 1999 in order to get a better understanding of tribal needs. Since then, the committee has been working on several projects:

Internet connection As the tribe grows larger and people move away from the service area, we need to look at ways to keep the tribe connected. With the tribe spreading throughout Michigan, Indiana, and across the country, the committee has been looking at ways to connect the tribe electronically. They are currently looking at ways to make sure every tribal member has a computer and an Internet connection. This will allow tribal members to have access to a Pokagon website to get current information. It will also allow members to keep contact via e-mail, though they may be hundreds of miles apart.

Dowagiac offices Possible office locations are currently being looked at to consolidate all seven of the Dowagiac offices into one site. Once this happens, tribal members will be able to visit all the tribal departments in just one trip. This is one way we are hoping to better serve our tribal members' needs.

Health insurance The committee is looking at ways to provide tribal staff members with health insurance cards to make their trips to the doctor more efficient. They are also looking at ways to provide health insurance to any tribal members who don't have access to insurance.

Watch for updates on the Strategic Planning Committee and their projects in upcoming issues of Pokégnek Yajdanawa.

Service Area

Efforts are underway to help the tribe better serve tribal members out of the 10-county service area. Much of the funding that the tribe receives is service-area based. This means that the tribal members that live outside of the service area are not eligible for such programs.

The legislation that was originally drafted to define our service area was mainly set up for tribes who were land-based. Since the Pokagon band has never owned reservation land, many of our members are outside of the 10-county service area. Thus they are not eligible for some of the programs that use service area-based funding and have rules that restrict provision of services to those members living in the service area.

It is important to tribal leaders to correct this. Options are being explored. The tribe is considering asking for a legislative change.

As of January 1, 2000, there are 1494 tribal members living in Indiana and Michigan. Only 902 of those live in the service area.

The 10-county service area includes the counties of Allegan, Berrien, Cass, and Van Buren in Michigan. Service counties in Indiana include Elkhart, Kosciusko, Laporte, Marshall, Starke, and St. Joseph.

Pokagon Population

As of January 1999, there was a total of 2,505 members. There were 1,494 living in Michigan and Indiana. The following charts are the populations in Michigan and Indiana counties. Counties in the 10-county service area are bolded.



STRATEGIC ACTION PLANNING COMMITTEE

SAPC MEETING MINUTES

05/31/00

Judy Winchester called the meeting to order at 7:10 p.m. at Elders Hall. Jo Ellen Leith gave the invocation. In attendance were Co-chairpersons Judy Winchester and Jeffrey Riley. Also in attendance were Patricia Klemm, Jo Ellen Leith, Mary Jo Morris, Corey Price, and Thomas Morris.

The April 19th, 2000 SAPC meeting minutes were reviewed and no corrections were requested or made.

The May 3rd, 2000 SAP discussion meeting report was reviewed and no corrections were requested or made.

Thomas Morris distributed a binder of business and economic development materials to each of the participants. An overview of those materials is attached to these minutes.

Jo Ellen Leith had an addition to the agenda and was asked to present her matter as the first agenda item. She discussed starting a revolving loan fund to aid businesses within the Band. First Nations has seed money grants available in the amount of five thousand dollars that may be used for planning such endeavors. She asked those present what the best use of that planning money would be. It was suggested that we contact Phillip Martin at the Mississippi Choctaw who is the Chairman of a very successful Tribe in regards to economic development. A point of discussion was inquiring how other Tribes recruit people to sit on oversight board of directors for specific programs. Another point was obtaining models of other Tribes' revolving loan programs for review. Jo Ellen briefly discussed the Lakota Fund, which is a successful revolving loan fun in Indian country. The Lakota Fund workbook is included in the binder distributed at this meeting.

Thomas Morris described the contents of the binder and discussed some specifics about the materials pertaining to the Small Business Administration, Lakota Fund's workbook, and FED's proposal regarding the Band starting its own Internet service provider. He stressed that all three groups of materials emphasize planning and self-assessment as major components to making a business successful.

Thomas Morris distributed update material to the Pokagon Band Education Survey 2000, which has totaled 356 responses. The material included the updated statistics for all thirty-three survey questions, Membership comments and concerns, and state and county demographics of the responses. Responses were received from twenty-five states and Canada. Also distributed were two memos from Tribal staff who had concerns regarding the survey or its publication.

The next SAPC meeting was scheduled for Monday, June 26th at 6:00 p.m. MI time at Elders Hall. [Due to scheduling conflicts, the next SAPC meeting was later moved to June 28th - tm]

Judy adjourned the meeting at 8:50 p.m.



Important Financial Aid Information

Students who are planning to apply for the tribal scholarship must apply for the Federal financial aid by filing out the Free Application for Federal Student Aid (FAFSA). The FAFSA application can be sent out any time after January 1, 2000 for the 2000-2001 school year. Generally, students need to allow about six weeks for the application to be processed and sent back to the college financial aid office. Therefore, it is in your best interest to start filing for financial aid as soon as possible to receive a good financial aid package at your school and to help avoid any "last minute" tribal scholarship problems. You need to apply for federal aid and fill out the FAFSA every year that you are attending school and are applying for the tribal scholarship. Tribal members can not receive a tribal scholarship without filing for financial aid first.


