#### NEW COUNCIL MEMBERS INDUCTED





It has been a terrific experience shaping programs and getting our services under way. I have so much to say about the people that work here. They're wonderful, caring individuals.



#### FINANCE REPORT

I would like to thank Tom Topash for his efforts as our Administrative Director. I wish him well in future endeavors. In his absence, additional responsibilities will be added to the individual program directors and coordinators to continue designing programs to address membership needs. Program directors and coordinators will be formalizing their respective designs of short and long-term program goals for Council to review within the next few weeks.

Once this process is complete, we will move forward in implementing these programs. The continued focus will be upon servicing members whenever possible. Some of this assistance may not always be in the form of financial aid. In-kind services such as referrals and accessing existing service programs will also be emphasized. Please make sure you continue to contact our staff for assistance. Hopefully, we will have a program to address your needs or at a minimum it could be the start of a new program. Continued communication from individual Band members either through various surveys, outreach workers, picking up the phone, or stopping by our offices is critical in addressing your needs.

To better serve membership and improve our overall office efficiency, we hope to be moving the administrative, financial and enrollment staffs under one roof. This will assist you in reaching any of us by just calling one number. As soon as this move is imminent, we will have a special mailer to announce the new address and phone numbers. It is anticipated the Pokagon Health Service Department will remain in its present location.

#### **GAMING REPORT**

The status of our lawsuit against the state of Michigan is discussed elsewhere in this newsletter and I have little to add to those discussions.

The status of our gaming development in Indiana is continuing, and it is independent of the process in Michigan. We continue to meet with interested community groups to advance the exposure of the Band and its goals to these communities. So far, much of our efforts has been addressing the informational needs of the City of Elkhart and its Casino Study Commission. Because we have not committed to an Elkhart

## COUNCIL MEETING SUMMARY OF MINUTES

AUGUST 10<sup>TH</sup> COUNCIL MEETING MINUTES

Matthew J. Wesaw, outgoing Chairman, gave a "THANK YOU" to the members, council and staff for all their support during his term of office as Chairman. He informed everyone that we have grown as a tribe and will continue to grow. He hopes that everyone will give the same support to the new council and continue to be involved.

Thomas Topash, Administrative Director, resigned to take a position with the Niles School District as Assistant Principal of the Ring Lardner Junior High School. He thanked the members, council and staff for all their support and said that "education is his love" and had an opportunity and felt he had to take it. Bob Moody wished him well and "THANKED" him for all his efforts as the first Administrative Director of the Pokagon Band.

Steve Winchester inducted the new and old council members. The council members are:

Robert J. Moody, Jr.- Chairman; Daniel F. Rapp - Vice Chairman; Thomas Morris - Secretary; Michael (Mike) Wesaw - Treasurer; Greg Ballew, Julie Stauffer, Barbara Ann Warren, Wayne Holleman, Kevin Daugherty, Sam Wesaw and Maxine Margiotta.

Marchell Wesaw informed the council that our land application is at the attorney for review and she will be talking to him on Monday, August 12, 1996. She informed the council we will need to justify our application when the time comes. She will get back to members and council after her conversation with the attorney.

Richard Klemm informed the council and members the Elders Council met and decided to elect officers on September 19, 1996. They will be electing a full board.

Bob Moody asked all Committee Chairpersons, Program Directors to have their reports to Gayle "Rusty" Green three (3) days before the monthly Saturday meetings. This will enable her to prepare packets for council.

#### **COMMITTEE REPORTS**

#### LEGISLATIVE REPORT

The Band, in conjunction with the Little River Band of Ottawa Indians, and the Little Traverse Bay Bands of Odawa Indians, have received the anticipated response from the Attorney General of the State of Michigan regarding the lawsuit filed in July. The State of Michigan has sought to invoke Rule 12 of the Federal Rules of Civil Procedure by requesting dismissal of the suit based on the 11th Amendment to the United States Constitution. This option is the direct result of the Seminole ruling earlier this year by the United States Supreme Court.

It is a response the Bands hoped to receive without delay. In response, the Bands have filed a response which will state in part, "Given the United States Supreme Court's decision in Seminole Tribe of Florida v. Florida, 116 S. Ct. 115 (1996), the Plaintiff Tribes cannot, and therefore do not, contest the State's motion..."

Based on this response from the Tribes, the Courts should dismiss the case.

Upon dismissal by the Court, the Tribes next step is to request a compact from the Secretary of the Interior. It has been suggested, and I agree, the Tribes should contact the Secretary collectively and immediately, asking that a compact be prescribed for the Tribes.

Understanding the current political climate regarding Indian gaming, other Tribes have approached the Secretary and we should not delay. Our facts support a clear picture of why the Secretary should prescribe a compact quickly. We currently have Indian/ non Indian gaming in Michigan. There are seven Indian gaming compacts which are working to protect the interests of everyone. The governor has agreed upon and signed compacts with each of the three Tribes. The Legislature decided not to concur with it. We have done everything suggested to us which should have caused the Legislature to support the tribes on the compact vote. Additionally, Rob Gips, who is handling the compact process, has been involved with the only compact in the country, which has previously been prescribed by the Secretary.

The procedure to be used by the Secretary in the prescription process for compacts will not be revealed before the November election. The original sixty day comment period, which was designed for responses regarding the Secretary's authority to prescribe compacts has expired (comments were filed on our behalf).

It is hoped the Secretary will waste little time in publishing rules supporting compacts for Indian gaming. The Secretary will publish recommended rules which will outline the process and allow a 60 day comment period. A final draft report will be generated and become effective 30 days after the final report. Congressman Kildee has been working very hard on behalf of the three tribes, as well as all Native Americans. He would like Michigan to be the first case taken by the Secretary. It would appear the Interior may be concurring due to the facts stated before.

It is entirely probable for the State to take issue with the Secretary, should he begin to prescribe compacts on behalf of Indian tribes. This could lead to litigation which will only delay our battle for economic freedom. We need to follow the best advice of our attorney's to succeed in this effort.

#### HOUSING AUTHORITY REPORT

We do not have any funds available, at this time, to assist members with loans or housing needs. In the future, the Band will be looking for and applying for any grants available for other housing needs.

The Director of the Chicago office of HUD. Francis Harjo will be at the September 7, 1996 Council meeting scheduled for 10 a.m. at PINI Hall. He will be there to answer any questions the membership may have about housing and HUD in general.

## POKAGON HEALTH NEWS

## INTRODUCTION TO CONTRACT HEALTH SERVICE (CHS)

Contract Health Services, or CHS, is one of the mechanisms this office has as an Indian Health Service program to provide health care services. CHS is the payer of last resort for some health care goods and services provided by non-IHS personnel for our eligible population. Health services that may be covered fall within priority levels in medical, inpatient and outpatient, dental, optical, prescription, and (life- or limb-saving) emergencies.

The CHS program must operate within a limited and fixed budget. Contract Health Service is neither an entitlement program nor an insurance program. Access to CHS is through authorization from the Pokagon Band of Potawatomi Health Office CHS staff. Specific eligibility criteria must be met for its use.

#### CHS ELIGIBILITY REQUIREMENTS

The person must be an enrolled member of the Pokagon Band of Potawatomi Indians.

The person must live within the ten-county Pokagon Band CHS Delivery Area (Allegan, Berrien, Cass and Van Buren counties in Michigan and Elkhart, Kosciusko, LaPorte, Marshall, Starke and St. Joseph counties in Indiana).

Some exceptions exist to these criteria: Full-time students are eligible if they were eligible prior to leaving the area to attend school. 180-day rule, eligible persons leaving the service area continue to be eligible for 180 days after departure. Non-Indian women pregnant with an eligible Indian's baby can access CHS for the duration of her pregnancy through postpartum (generally, the 6 weeks following delivery).

#### **AUTHORIZATION FOR CHS**

No payment for health care will be made without authorization from the Pokagon Band CHS staff. A payment voucher must be prepared prior to receiving health care goods or services.

In an emergency, the eligible client has 72 hours to notify the CHS staff. If the client is 65 years of age or older or is disabled, the client has 30 days to notify the CHS staff of the initiation of emergency care. Use of the Emergency Room for non-emergent needs will not be covered by the CHS program. Emergent needs must be so described as emergent or directed as emer-

gent by a physician to be covered with CHS funds.

CHS is the payer of last resort. All alternate resources must be utilized first before payment through CHS can be considered. This is the law. Alternate resources are any insurances and/or state or Federal health programs for which a person is eligible. Our Benefits Specialist, Lois Wesaw, is on staff to help you through this process of accessing alternate resources.

#### GLUCOMETER EXCHANGE PROGRAM

We are working on a glucometer exchange program. The type of glucomemter is the Miles Labs' Encore meter for Diabetic in-home monitoring of blood glucose levels. More information about the exchange program will be given as the details and plans are finalized possibly within the month of September.

#### VISION ADVANTAGE PROGRAM (VAP)

In two weeks RX Optical Vision Advantage Program (VAP) informational brochures and cards will be ready for distribution to our membership. Upon presentation of a VAP card at an RX Optical store, the bearer can receive 30% discounts on optical services and products from the RX Optical company. These services include eye exams, frames, lenses and contact lenses. A one-year eyeglass warranty for repair or replacement of damaged or broken frames or lenses is included in the Program. There is no limit on frequency of use. You can purchase more than one pair of glasses or lenses per year. And the VAP can be used with vision insurance programs.

Unlike Contract Health Services, the VAP is available to all of the approximately 2500 Pokagon Band members regardless of county of residence. Non-member spouses and families are eligible for this program's coverage as well.

RX Optical has more than 30 locations throughout Michigan, including but not limited to ten stores in Grand Rapids and four stores in Kalamazoo. Indiana Pokagon Band members may use any of the Michigan locations: Niles, Sturgis, Coldwater and Three Rivers may be the most convenient sites for them to use.

#### PATIENT REGISTRATION PROJECT

Pam Mersereau, our patient registration clerk and office receptionist is beginning a preregistration project of all eligible members. Preregistration is required for access to IHS programs.

The Indian Health Services stresses the use of social security numbers for registration. In fact, the IHS plans to use the social security number as the primary identifier of eligibility for IHS services and care. Because of this, Council approval was sought and received for access to Pokagon Band member social security numbers on file with the Enrollment Office. This permission was granted on condition that any member who wishes to have her/his Social Security Number withheld may do so by contacting the Health Office and informing Pam that this is her/his desire.

#### **HUMAN SERVICES DIRECTOR**

I am very excited about human services that are in place, and some of the programs still being developed. Here are a few highlights:

We have completed the last of the ANA grant Surveys. Thanks to all those who participated in this survey. This information will be used to determine what services are needed most by the members of the Band. A strategic planning task force is being formed to discuss the findings of the survey. Also, the task force will discuss how to implement the programs to meet the needs identified. About 130 members participated in the survey. While this information is very helpful, I still welcome input from members as we continue to develop new programs.

COMMODITIES—Candace Brumley and Phil Alexis, Jr. continue to manage the Commodities Program. Currently, we are serving about 30 families. We have started an outreach effort to reach more members who may benefit from this valuable food program. Call Candy or Phil at 1-888-281-1111 for more information. They can tell you about eligibility, the kinds of food offered, or any other questions you may have.

CHILDREN'S TRUST FUND GRANT—We have been awarded the Children's Trust Fund Grant. This money will help pay for an Outreach Worker to conduct parenting skills classes, make sure children are immunized, and workd towards reducing incidents of child abuse and neglect. The focus is to keep our families together, with the types of services needed to address the issues facing families in our communities.

bor of the Domestic Violence Task Force in Cass County. There are services available in the area for women who are in need of help. Please call if you need assistance in this area. I can refer you to the most appropriate agency for help. Also, I will continue to provide whatever help I can for Child Welfare issues, such as out-of-home placements, custody,


