### RED ROAD POW WOW AND LITEFOOT HIT DOWAGIAC

The Red Road Pow Wow in Dowagiac March 22 and 23, welcomed people from all over. Many Band members attended to dance or drum or just to shop. The more than 30 traders displayed their beautiful art and jewelry. There was also delicious food to be sampled with pow wow staples like fry bread, blanket dogs and Indian tacos.

The traditional pow wow included many inter tribals and the always popular two-step. During the pow wow the JOM students were treated to a talk by Native American rapper Litefoot. The Cherokee has been in several movies, including a starring role in *Indian in the Cupboard*. His message was a positive, uplifting one for the youth. He spoke of the need for young people to learn the history of all Indian people, not just their own tribes.

He spoke of his own success and encouraged the

youths to follow their dreams. He also added that they must not let others pull them down. For many of the younger kids, the question and answer period was fun. Litefoot answered questions ranging from how they made him so small in the movie *Indian in the Cupboard* to who was his inspiration.

Litefoot also rapped his message later that night. He again spoke of the need for education and pride in yourself. You must worry about yourself and believe in yourself. His concert was popular with the youth who danced the night away to it, but he also reached the Elders. Many of them enjoyed the concert and his visit with them Friday evening.

The pow wow wrapped up Sunday with more dancing and traditional drumming. The proceeds of the Red Road Pow Wow benefit the establishment of a half-way house in Southwest Michigan.

### M.A.S.T. IMPACT WEEK

The Midwest Alliance of Sovereign Tribes held its first meeting in Washington D.C. on March 10-13, 1997. The group formed to help protect tribes' sovereign rights.

Its goal for the inaugural meeting was to educate lawmakers on Native American issues. The 104th Congress tried to pass many anti-Indian laws. Many of those attempts eroded at Indian sovereignty. From land in trust issues to heavy taxes on Indian gaming, the effects are the same. Any law that impacts these issues can damage the self-determination that tribes are attempting to achieve.

The Alliance is formed by 34 federally recognized tribes throughout the Midwest. The goal is to educate Congress and Senate on tribal sovereignty. For many of those politicians there are no tribes in their area. The goal of M.A.S.T. was to educate the lawmakers without significant Indian populations.

The group accomplished those goals. After the week ended, the tribal representatives had visited more than 185 offices on both the House and Senate side. Kevin Daugherty and Maureen Shagonaby attended as representatives of the Pokagon Band.

The trip was a success. The two met with Congressman Fred Upton and encouraged him to join a Native American caucus that is starting in the House. It is a bi-partisan effort co-chaired by Congressman Dale Kildee and Congressman Patrick Kennedy. Upton was very interested and plans to participate in the Caucus.

Although it was important to meet with the Michigan politicians, the most crucial visits were to those who had little knowledge of Indian issues.

### GAMING UPDATE

Michigan-

No further progress to date. There has been a Detroit newspaper article where Speaker Hertel indicated it was possible legislative language on proposal E would be taken up by the legislature in April. If this is the case, our resolution in support of the compact should follow when the proposal E process is completed. Little River's management company, who is also involved with the Detroit process, is saying our compacts will be completed in June. We are continuing to keep contact with legislators to develop strategies to make sure our compacts move as promised.

Congressman Kildee's office has been in contact with the Interior Department about their intentions in acting on behalf of the Pokagon Band and the other Tribes in Michigan. As of late, the communication is another meeting will be held with the Department of Justice in April, and we should expect word by May 1. Keep in mind the Interior Department is trying to come up with a solution which will be able to withstand potential legal challenges. Their options are to file a lawsuit on behalf of the Tribes or prescribe a compact themselves. In any event, we will not be able to proceed until the Interior Department and Department of Justice is ready to move forward.


#### Indiana-

A myriad of potential legislative activity has been taking place in Indiana trying to stifle our efforts while protecting existing and other gaming interests. Senate bills have been passed to prevent compact negotiations and a land base casino. However, these bills are currently in the House with no prospect at this time of being heard. There exists a real reluctance on the part of the House to pass any legislative language surrounding gaming. Especially, legislative language which may tie the hands of the state in the future as it relates to IGRA. A compromise bill is being developed whereby compact negotiations may be allowed given certain conditions. We have not seen this language and should have it in the near future for our comments. It appears we are able to have good communications with a variety of legislators through our lobbyists in Indy. They have been working hard on our behalf, and they are well respected by the General Assembly. They have been effective in educating certain key legislators and the governor's office on the real issues surrounding the Pokagon Band and Indian gaming.

Governor O'Bannon has made public comments on the compacting issues where it seems he has changed his position from favorable to unfavorable. Much of this had to do with our good buddy Congressman Roemer. Roemer continues to misinterpret everything from federal law (IGRA) to land in trust issues in communications with the Governor. However, we have been successful in repudiating his misrepresentations on these issues. Until the governor studies these issues further he should be abstaining from any more public comment.

Locally, the South Bend City Council was considering passing a resolution to support a moratorium on gaming and prohibiting land based casinos. Fortunately, this resolution was tabled in committee pending further study.

Education of the issues will be the focus of the Indiana negotiating team in Indiana. We will be meeting with a variety of organizations to garner grass roots support. There has been support from labor and minority leaders which will serve helpful to our efforts.

### **COMMITTEE REPORT**

When the legislative agenda for our compact approval process started, we encountered several obstacles. The biggest of these obstacles was timing. Unfortunately the Pokagons had no control of the timing, as well as the political climate. We were asked to be patient, and told the Compact would become priority at different intervals. We were advised to get involved in the political action arena. Everything we were asked to do, we complied with. We extended our patience, we supported those who were helping us, we agreed to change our casino site, we kept our frustrations from the media, we didn't attack the political process, we believed those who talked to us, assuring us that "it would get done". Well, my friends, my frustrations have peaked.

The Compact vote late last spring failed in the Senate. The debate centered on the argument, until Detroit is approved for casino gaming, we will not support anyone else having it. A referendum was approved in November of 1996 giving Detroit three casino licenses. Detroit now has the authority to game.

The Pokagons have been told there is support from the Governor and the Republican controlled Senate for passage of our Compact Resolution. I would like to believe this, but I am no longer sure of what I hear. The House leadership has said they support our Compact. But, before it will act on the Resolution, Speaker Curtis Hertel wants assurances that the Governor will not hinder the implementation of Proposal E (casino gaming for Detroit). The Governor began almost immediately with the implementation of Proposal E. I spoke to Hertel in early March about the lack of progress on the Compact Resolution. I advised him that I would recommend to the Tribal Council we look to Washington for relief. Speaker Hertel asked for a two-week delay. He thought he could work out an agreement to meet everyone's needs. Two weeks later, in my conversation with the Speaker, he told me, "I can't get it done, do what you have to do (go to Washington), I understand."

I would like to lay total blame on the political process, but I can't. We have to accept partial responsibility. We have not required our voice to be heard on all matters in the strategy used to get the Compact through. To use a politically incorrect term, there are too many chiefs and not enough Indians. The chiefs have the same goal in mind, they just aren't on the same page. We can correct this, but there has been damage done.

While all this political rhetoric and posturing is

going on, we are being denied the ability to provide our own economic well being, and establishing our own future.

Additionally, Windsor is smiling. The longer this fight goes on, the more money they make. Casino opponents are given more time to develop legislative language to stall, eliminate, authorize more government control etc., over gaming in Michigan. The court challenge on Proposal E is gearing up, which if filed, will delay the implementation for an unknown period of time.

I don't argue the need for strong regulatory authority over state run gaming, but, Indian gaming has not shown the need for additional state regulatory power. The current regulatory system for Indian gaming is sufficient. It is more regulated than all others.

Within the last month there have been at least 10 new pieces of legislation introduced which will impact the gaming industry if passed. One is a resolution, which if passed by both the House and Senate, would place on the ballot during the next election a constitutional amendment to make gaming illegal.

We knew early in the legislative process our timing was bad, however; we accepted the delays, met with all who asked, and believed what we were told. To what end? We are still a pawn in a game we don't want to play, and a pawn the parties really don't care about.

I have said it before, and I will say it again. Washington should be the focus of our strategy now. This is not to say our Compact may not get State approval, but we can't accept the excuses and delays the politicians are supplying. It is obvious we are not a factor in their game. If it happens great, but we need to move forward. We need to petition the Secretary of the Interior for quick action on the subscription process. We have spent our time and energy laying the ground work for the Secretary to support us. It is time to see if their words will lead to action.

Frustrations with the political process are nothing new, as our government grows we will run into this quite often. We can't let this frustration lead to alienation. The political process is the vital part of the democratic process. We can only ask for fairness and equal treatment. We will continue to be in contact with our legislators, letting them know our feelings. You should too.

The Anishnabeg have always been regarded as a spiritual people. Even today the Anishnabeg still have strong spiritual beliefs. It is because of this, that we are now faced with a situation that will benefit the people of the Pokagon Band of Potawatomi Indians, descendants of the Anishnabeg.

We, the people who originally thought of the Spiritual Gathering, have chosen to be called the "Spiritual Gathering Committee". We would like to express to you the motivation behind this group of people. We have no formal way of governing ourselves other than we have established to operate as our ancestors did. Our decisions are formulated through the general consensus method. We've chosen not to have a chairperson, but have selected from among us a spokesperson. Our committee has been working in conjunction with the Pokagon Band Indian Health Services, as well as other departments of our tribe to sponsor this event.

We have for some time now, been considering having an event of this magnitude. We've chosen a spiritual leader from the Prairie Band of Potawatomi Indians to conduct this gathering. Dale Thomas, a Spiritual Leader has been contacted and consented to be in charge of the Gathering. Please keep in mind it is our inherent right as Anishnabeg to be able to hear and share in the teachings of the Original Instructions. What the people decide to do with them is entirely up to them, as long as all is done in a good way.

The time and place will be announced in the near future. The Gathering will consist of four days of teachings, spiritual fire, daily feasts, talking circles, Pokagon Community involvement and togetherness, social drumming and dancing each evening. All Pokagons are strongly encouraged to attend!

Elders would benefit from the love and respect generated from the Gathering. This is what they rightfully deserve and should be given at all times. As you can clearly see all would benefit from this endeavor. After all, community is part of what being Anishnabe is all about.

### ATTENTION POKAGON BAND MEMBERS

This is some information on what I am trying to do for the band members who are low to very low income. I am trying to get as much information as I can about anyone who needs some type of work done to their home. Of course, just like the rest of the programs that I have, you must own your own home.

In order for me to try to get this grant through HUD for renovations, I must show how much money I need and where I will be spending it. I also have to have some type of waiting list to show them. There is a lot of foot work to be done to get this grant through. I need this information as soon as possible because the grant has to be turned in by May. We won't know about the grant until October.

I am asking that you make a list of home improvements that you need and get two itemized bids from licensed contractors. Send them Attn: Keith White (901 Spruce St. Dowagiac, MI 49047) I will also be working toward getting funding for those who won't qualify under the low to every low income guidelines. Right now, I don't know what the income guidelines are until HUD releases the new federal register which should be any time. If you have any questions, about this please call me at 1-888-330-1234.

The only thing that I ask of you is to get two itemized bids from two licensed contractors and send them in with your application. You can find them in the yellow pages under general contractor or home improvements. I have the numbers for the few Indian contractors that we have. If you call, I can also give those to you. ### INDIAN HEALTH SERVICES

### Health Screening

A Free Health Screening for Pokagon Band members is scheduled for March 27, 1997 in the classrooms at Lee Memorial Hospital. The hours are 7:00a.m. to 11:00 a.m.. Mammography appointments are available until 5:00 p.m.. This health screening is aimed at adults, however, some tests could be appropriate for children. PSA will be drawn to check for prostate cancer in men. Mammography will be available for women 40 years and older. If abnormalities were noted on clinical breast exam, a physician or nurse practitioner may refer a younger woman for mammography. CBC's and chemistry profiles will be drawn for information about anemia, cholesterol differentials (good vs. bad cholesterol levels) and blood glucose readings. Height, weight and blood pressures will be checked. A weight goal and an eating plan for gradual and healthy diet modification will be provided.

Other screenings and information will be provided this day. You can pick and choose which tests you wish to undergo. As an incentive for our members to complete more than one test, a massage therapist will be on site to perform neck and shoulder massage to clients who complete multiple tests.

The screening is free to all Pokagon Band members regardless of County of residence. We will apply Contract Health Dollars where appropriate.

Some tests require at least a ten hour fast (overnight). Snacks will be provided post test.

#### **Contract Health Services**

Contract Health Services (CHS) is a program that can be used to purchase some health care services for eligible Pokagon Band members living within our Contract Health Service Delivery Area (Allegan, Berrien, Cass, and Van Buren Counties in Michigan and Elkhart, Kosciusko, LaPorte, Marshall, Starke and St. Joseph Counties in Indiana).

Contract Health Services requires prior authorization: You must be pre-registered in the Patient Registration System through our office; you must notify Pokagon Band CHS staff of each and every medical service BEFORE you go to those appointments to which you wish to apply CHS. In other words, call our office,

speak to Lois Wesaw, fill out the Patient Registration form and remember to call before each medical, dental, eye service and pharmacy service. In keeping with IHS policy, the Pokagon Band Health Services cannot authorize CHS payments without prior authorization.

CHS is the payor of last resort. This program pays after all other insurance and state program resources have been exhausted for each client. Therefore, to use CHS, each client must present proof of insurance or ultimate denial. In other words, you will be asked to present your insurance cards. If you have no insurance, you will be directed to apply for state programs and federal programs. You will be referred to FIA (formerly DSS) to apply for Medicaid, General Assistance, Medicare and Caring for Children programs.

#### Sister Lakes Medical Center

Beginning March 25, 1997, Pokagon Band Community Health Nurse, Mark Topash, RN, will be at Sister Lakes Medical Center on Tuesday mornings and Thursday afternoons. He will be available to perform follow-up nursing treatment and to conduct patient education for our Pokagon Band clients. He will be working with Ed Newington, PA at the clinic.

### Indian Health Services Competitive Scholarship Deadline

These are the last few days before the Indian Health Services competitive scholarship deadline date, April 1, 1997. The scholarship is open to American Indians and Alaska Natives only. The scholarship intent is to train health care personnel for service to American Indian and Alaska Native populations. We still have a handful of applications on hand in the offices. Call with questions, but hurry.

The Elders traveled to Hayward Wisconsin on Friday, February 28, to attend the dedication ceremonies for Jim Thorpe. The Amateur Athletic Union returned National Qualification Medals to Thorpe who is called the greatest athlete in the world.

Thorpe's family accepted the medals in a ceremony hosted by Lac Courte Oreilles Band of Lake Superior Chippewas. Thorpe died in 1953 leaving behind a tremendous legacy. The Amateur Athletic Union voted unanimously in 1913 to strip Thorpe of his Olympic gold medals and trophies and eliminated his records because they ruled he was a professional athlete.

Despite that he had many accomplishments. He gained a great deal of recognition after a stellar football career. In 1950, the Associated Press name him the Greatest Football Player of the half-century, and also bestowed him with the title of Greatest Male Athlete of the half-century. Two years later the N.F.L.'s Most Valuable Player award was renamed the "Jim Thorpe Trophy."

In 1982, the Executive Board of the International

Olympic Committee voted unanimously to restore Jim Thorpe's Olympic gold medals. This was the final victory for Thorpe's family as they received his qualification medals this year.

The Pokagon Elders had a wonderful time. They were also honored to see this ceremony, honoring the man many believe to be the greatest athlete of all time.


