I ended a meeting of the general membership on May 30th and was approached by many that expressed the desire for me to return. I spoke to our Chairman and learned of several openings in our Economic Development area. I asked to be considered and was notified on Monday, June 8, that the selection process is beginning. I had hoped the process wouldn't begin this soon, for I would have liked to finish my contract. But business won't wait for me, and I must take hold of the opportunity.

HEALTH BOARD SEEKS MEMBERS

The Pokagon Band of Potawatomi Indians Health Board is seeking interested Band members to come forward to volunteer for Council appointments to a 3-year term on the Health Board. If you are an enrolled member of the Pokagon Band and are interested in being considered to serve, let Pat Wattles or Christine Daugherty know of your interest. You can reach either person at (616) 782-4141 or 1-888-440-1234 during business hours. You can leave a message with your telephone number on the machine. The other option is to notify any tribal council member of your interest and the member can bring it forward to the Health Office staff

The purpose of the Board is to shape health policy to ensure fair and equitable health service delivery to eligible clients of the Pokagon Band Health Services. The Health Board meets two times a month on the first and third Monday of every month, weather permitting. Meetings are held in the lobby of the Health Office at 210 Front St. in Dowagiac.

Contract Health Services

Patient Registration and Contract Health Services are conducting an annual review of client registration files. This letter is currently being sent out to our clients. If you receive a letter about specific documentation that is needed to complete your files and have any questions, please call Pam Mersereau, Patient Registration Clerk or Kim Falk, and they will be happy to answer your questions to help update your files.

Payment Process

If you feel you are experiencing slow CHS payments to your providers, call Lois Wesaw, Pam Mersereau at the Health Office. If you call after business hours, leave a message on the machine and someone will return your call as soon as possible.

PLEASE REMEMBER IF you request CHS payment for your medical, dental or prescription services, this office needs a copy of:

- . The Bill
- 2. The Explanation of Benefits (EOB) from your insurance relating to the bill in question if you have insurance coverage. IF you do not have insurance, you must provide current proof of denial from the Family Independence Agency stating that you are ineligible for its assistance programs.

Without the bill or the EOB (current proof of denial), Contract Health Services staff CANNOT process payments on your behalf.

Walk, run or mail these crucially important documents into our office as soon as you are able. Do not wait, you are not doing yourself or us a favor by holding these documents to send in during a "slow" period. There is no down time or an off-peak season in health.

There have been 2,400 CHS payments and vouchers for payments generated in the past 12 months on behalf of the 700 active clients listed in our offices. These 700 clients have accessed 250 providers throughout the Contract Health Service Delivery area and beyond.

Eyewear Program

On Wednesdays Trish Williams and Susan Beavers scheduled hours to help our eligible clients choose eyewear according to your optometrist or ophthalmologist's prescriptions. We have more than 140 frames to choose from, including safety frames. Call for hours and program guidelines.

Emergency Funds

Reminder of changes to Emergency Funds:

- 1. As of March 2, 1998, all applications for emergency funds will be taken to the Emergency Fund Committee meetings on Mondays at 10 a.m. No determinations will be made by phone except for requests for funeral assistance. This will improve the review process by allowing committee members time to consider all information submitted with the request.
- 2. As of November 20, 1997, Tribal Council passed a resolution to "remove the Low Income Home Energy Assistance Program (LIHEAP) from the Emergency Fund Program and let it stand alone." Since that time, all energy assistance is provided through LIHEAP. Eligibility is based on income and the participant is responsible for providing proof of 30-day income and vendor information to qualify for assistance.
- 3. As of October 1, 1997, the Emergency Fund Program is only available to enrolled Pokagon Band members located within the 10 county service area. At that time, there was a change in funding from the general fund to '638 monies' (federal fund); therefore, federal guidelines apply, which limits eligibility to the service area.

FOOD COMMODITY PROGRAM

To qualify for the commodity program:

- You must be Native American
- You must live in the 10 county service area in a city with a population of 10,000 or less.
- You must report ALL members of household.
- You must provide verification of household income.
- You must report any changes in household composition and/or income within 10 days.
- A household may not be enrolled in the USDA Food Stamp AND Food Commodity program at the same time.






