

POKAGON HEALTH NEWS

BASIC CONTRACT HEALTH INFORMATION

For Contract Health Services to make payments on your behalf for your health care services you must:

- 1. Be a Pokagon Band member.
- 2. Live within the Contract Health Service Delivery Area
- 3. Register for Contract Health Service benefits. This includes providing our office proof of your insurance or if you have no insurance, you must provide to this office a copy of the denial letter from your local Family Independence Agency. You will be asked to update your file once every 12 months and on an ongoing basis as you make requests.
- 4. Seek prior authorization at least three working days before scheduled health care appointments. You must request CHS coverage before you go to your appointments. Seek separate authorizations for all follow-up appointments, treatment plan follow-up dates, plus any and all labs. CHS cannot pay for health care services without prior authorization.
- 5. Seek authorization within 72 hours of the start of emergency or urgent care. Elders or disabled clients have 30 days to notify our office in case of emergency care.
- 6. Get copies of provider bills to our office. Without the bills, payments cannot be processed.
- 7. IF you have health care insurance(s), you must provide copies of your insurance Explanations of Benefits (EOBS) to our CHS staff. The EOB is the paper from the insurance company, which explains what they have paid and the unpaid balance. Without an EOB, payment will not be processed.

We have Contract Health Services staff people available to assist you. Please call with your questions.

POKAGON SOCIAL SERVICES

EMERGENCY FUNDS

The emergency fund is available to help families and individuals through emergency or disaster situations to regain self-sufficiency. The fund is to be used only in cases that clearly constitute an emergency after other funding sources have been exhausted. Sinking financial conditions, while regrettable, are not defined as an emergency. In order to help as many households as we can within our budget, there is a maximum amount that may be awarded per year, per household. The emergency fund is available in the 10-county service area (since 10/97), and cannot be used for rental deposits or used for the same thing for two years in a row. Effective 8/24/98.

Outreach workers are available to help with your individual situation to coordinate and link services needed to help with a long term solution by making referrals to the JTPA program, food commodities, debt counseling, Social Security, or other resources that may apply.

<u>USDA Food Distribution Program on Indian Reservations (FDPIR)</u>

- *Supplemental Food will be available at the Food Commodities Building beginning September 29th. Only available while supplies last. See insert for details. ALL ENROLLED POKAGON BAND MEMBERS ARE ELIGIBLE, REGARDLESS OF INCOME OR COUNTY OF RESIDENCE.
- *Monthly food commodities are available to Native Americans who reside in the 10-county service area in a city of 10,000 or less and meet income guidelines set by the USDA (example: monthly net income of less than \$792 for a household of 1).
- * Reminder: Dual participation in the FDPIR (commodities) and Food Stamp program is illegal and subject to losing benefits of both programs and/or fraud charges. There is a penalty for dual participation because the USDA is the funding source for both programs and collecting from both is considered 'double dipping'. Commodities staff can help you to switch from one program to the other if you are interested in doing so.

LIHEAP

The energy assistance program had a positive closure 6/1/98 after exhausting funding for the program year.

Over 140 families utilized the program, which included more than 445 household members. This program will be available again in October 1998. LIHEAP is available to members residing in the 10-county service area who meet the income guidelines (example: monthly gross income of less than \$1,377 for household of 1).

Injury Prevention

Fire extinguishers are still available in the Social Services Office. Tell your friends and family! We hope that you will never have to use them but, as they say, better safe than sorry! ALL ENROLLED POKAGON BAND MEMBERS ARE ELIGIBLE, REGARD-LESS OF INCOME OR COUNTY OF RESIDENCE... in order to maintain some semblance of order; please plan to pick up (only) your own fire extinguisher. Thank you for your cooperation.

JTPA

The JTPA program is a job-training program for individuals who may be economically disadvantaged, unemployed, or underemployed. Our JTPA program is specific to the Native American, Nat Alaskan or Native Hawaiian population in the service delivery area. Interested? Please see Mike Zimmerman, Senior Training Specialist in the Social Services Department or call (800) 517-0777.

ICWA

The Indian Child Welfare Act is a federal law passed by Congress in 1978 to protect Indian families and tribes from the removal of their children in state court proceedings and is designed to preserve Indian tribes and families. ICWA applies to cases in state court where a non-parent seeks to remove an Indian child from the home or control of its parents or Indian custodians. This typically occurs when Child Protective Services (CPS) files a petition in court charging the parents with neglecting, abusing, or abandoning their children. Foster care or adoptive placement is often sought in these situations. The Act also applies when the child is charged with wrongdoing, which would not be considered criminal if done by an adult, such as truancy. More next month...

- --Performs highly responsible, professional secretarial and administrative services for the Pokagon Band Tribal Council, Elders Council, and assigned committees.
- --Attends Council and assigned committee meetings to take dictation and transcribe notes into meeting minutes, correspondence, etc.
- --Prepares and disseminates Tribal Council packets per prescribed timeline.
- --Responsible for the orderly establishment, maintenance and retrieval of filed information and correspondence on a daily basis to ensure immediate access to file data for execution of Tribal Council business.
- --Prepares reimbursement requests for Tribal Council, Elders Council, and committee expense requests, per diem, conference/travel payments, etc.
- --Coordinates Council and Committee calendar, including the Pokagon Band meeting and events calendar for usage of Elders Hall.
- --Makes conference/seminar reservations and travel arrangements for Tribal Council, Elders Council, and committee members.
- --Arranges meeting sites, conferences, special events, etc. as directed by Tribal Council.
- -- Maintains confidential files of Council/Committee related business.
- --Reads and routes incoming Council/Committee mail according to internal policies and procedures.
- -- Facilitates dissemination of information to membership as directed by Tribal Council.
- -- Ensures arrangements are made and needs are met prior to meetings, such as appropriate materials, audio/visual equipment, coffee, food, etc.
- --Ensures meeting site is back in order following use.

Marge Moody moved to approve agenda of July 2, 1998. Mary Church seconded the motion. All in favor 'aye", opposed 0. MOTION CARRIED

Fred Klemm moved to approve the minutes of June 4, 1998. Rachel Daugherty seconded the motion. All in favor "aye opposed 0. MOTION CARRIED

Rachel gave her MCIA report. She stated that in 1964, Governor George Romney appointed a study commission to look at the problems of the Indian people. The result of the efforts of that commission was a recommendation that a permanent body be established. In 1965 the first commission consisted of eleven (11) active Members appointed by the Governor. Their purpose is to investigate problems common to Indian residents of the State. Matthew Wesaw is a Member of the Commission in the Lansing area. Their next meeting is August 13th and 14th. in St. Ignace, MI. One of their concerns now is a census coming up. A Commission has recently been formed in Indiana with Mike Wesaw serving as Chairperson.

Marge read the Quorum By-Law; Pg. 8 Sec. 7 (B). She opened up discussion as to whether we want to change the 30 minute wait in case one of us couldn't get here on time. Membership wants to leave it as is. Gerald asked Membership if they wanted to change the August 13th business meeting and luncheon to August 6th. 15 voted yes. COMMUNITY DEVELOPMENT

RADON GAS MEASUREMENT PROGRAM

PBPI through the Michigan Inter-tribal Council Inc. Environmental Services Division will be conducting a radon gas measurement program in November-December of this year for Pokagon Band members. Members who are interested in participating in this program, may call David Alexis, Community Development Director at 616-782-1763 or 888-782-1001. The following information is provided by Dwight Sargeant ITCM Environmental Services Division.

Radon is estimated to cause thousands of deaths each year. In fact. the Surgeon General has warned that Radon is the second leading cause of lung cancer in the United States.

Radon is a natural occurring colorless, odorless gas that is formed through the breakdown of Uranium in soil, water and rock. Radon typically moves up through the ground to the air above and into your home through cracks and other holes in the foundation. Once inside the home Radon gas becomes trapped and accumulates.

Nearly one out of fifteen homes in the U.S. is estimated to have elevated Radon levels. While Radon problems may be more common in some areas, any home may have a problem. The only way to know about the radon levels in your home is to test!!!

A variety of methods are used to reduce Radon in homes with elevated levels. In some cases, sealing

cracks in floors and walls may help, in other cases a simple system using pipes and fans will remove radon gas from below the floor before it can enter the home. Charcoal activated test kits will be initially used to measure the Radon levels. The Inter-Tribal Council of Michigan Environmental Specialist will deploy and pick-up each kit. Each kit must be left in each home for at least four days.



Neshnabemwen


Bozho, I would like to take a moment to introduce myself. My name is John Fox, and I have recently accepted the position of Language Development Specialist. I am a Pokagon Band member, and my family and I live in Saugatuck. Judy Augusta, Majel De Marsh and myself have just returned from Haskell Indian Nations University in Lawrence, Kansas, where we participated in this year's Potawatomi Language Scholars College. This was the second year of a three-year program designed for people interested in learning and maintaining the Potawatomi language. It is important to understand how critical a language program such as this is, not only for the Pokagon Band, but for all Potawatomi bands as well. It is generally understood that there are only about 50 speakers of Neshnabemwen left nation wide. All of these speakers are elderly, and unfortunately, there is not a new generation of speakers behind them. The Potawatomi Language Scholars College is attempting to work with members from all bands and all levels of speech to help people have a better understanding of their language and work towards becoming a more fluent speaker.

In the months to come, I will attempt to develop various ways of presenting Neshnabemwen to the Pokagon Potawatomi people. I will be focusing on programs that will be user friendly, as well as practical for daily use in and around the house. Also, keep an eve out for the monthly language page in the newsletter.
