POKAGON POW WOW HEATS UP SOUTH BEND

Kee-Boon-Mein-Kaa '98 was a mixed bag of things. So-so attendance, enthusiastic drumming, horrible weather and competing with a home Notre Dame football game made for a busy weekend.

On Saturday, it was a warm day with lots of dancing and singing. Head dancers Candi Wesaw and Donald Sumners had their work cut out for them. They led the dancers into the circle for a very exciting and beautiful grand entry. The Head Veteran was George Martin. With several different drums in attendance, there was plenty of variety in singing, and Smokeytown hosted the overall pow wow. Throughout the afternoon there were many inter-tribals as well as some fancy exhibition dancing.

There was a steady crowd on Saturday, and spectators not only got to enjoy the dancing, there were some excellent traders in attendance. Also, the food was good, no matter which vendor you chose. Band members could also visit the housing, health and education departments. Staff made themselves available to answer questions and

talk to the membership.

That evening, the annual teen dance was a success. The kids really enjoyed the dance and they helped the d.j. with his selection. The dance started about 9 p.m. and ran until 11:30 before the last song closed it down.

On Sunday the busiest booth at the pow wow was health. The temperatures soared into the high 90's with extreme humidity. At one point, health reported that 11 people visited the tent suffering from heat related problems. The attendance was sparse on Sunday, but the weather was awful. It was so hot, it was hard to believe it was Labor Day weekend.







Christine Morseau tries to beat the heat while her son fans her. But JoEllen Leith is on her own trying to stay cool.

LEAKS LEAD TO CHANGES

In late August the South Bend Tribune wrote two articles in which the tribe's minutes were quoted. Someone saw fit to release them to the media. The minutes discussed two of our most private issues, land and gaming.

These two areas of tribal planning must be considered private because of the problems that arise when anyone finds out about our plans. The tribe purchased a parcel of land in Indiana, and we used a limited liability company to do so. When people know we are looking at land, oftentimes they panic. They assume it will be used for casino, and that makes people very nervous. The tribe actually has not decided what to use the land for, but when you tell outsiders that, they don't necessarily believe it. We know we have other pressing needs to address such as housing and tribal offices, but that does not occur to people.

Because this reporter had the discussion portion of our minutes, he was able to disclose the LLC's name and render it useless for us in the future. He also disclosed that we were looking at additional acreage near our property. This information gives anti-casino and anti-Indian groups and people an opportunity to buy this land out from under us. It was important for that to stay quiet.

The other portion of the article made reference to Harrahs. The paper speculated that we are nearly out of money because the end of our agreement is coming closer. That is simply not true. But the most disturbing factor is the media does not have a right to our minutes. The discussion surrounding Harrahs should have remained within our Band. And it would have, if someone had not sent it to the newspaper.

At the last Tribal Council meeting, Council passed a resolution stating that minutes will not be handed out upon request as they had previously. This may seem like Council is punishing the masses for actions of a few. But it is equally important to remember that the damage that can be done to the **ENTIRE TRIBE** by these leaks could be irreparable. At this time resolutions will not be printed in the newsletter.

We are at a very sensitive time in our tribal history, and Council was forced to do what was in the best interest of the membership. Gaming and land issues are two of the most delicate issues the Tribal Council handles. It may not always have to be this way, but for the time being, access to this information must be limited.

POKAGON HEALTH NEWS

BASIC CONTRACT HEALTH INFORMATION

For Contract Health Services to make payments on your behalf for your health care services you must:

- 1. Be a Pokagon Band member.
- 2. Live within the Contract Health Service Delivery Area.
- 3. Register for Contract Health Service benefits. This includes providing our office proof of your insurance or if you have no insurance, you must provide to this office a copy of the denial letter from your local Family Independence Agency. You will be asked to update your file once every 12 months and on an ongoing basis as you make requests.
- 4. Seek prior authorization at least three working days before scheduled health care appointments. You must request CHS coverage before you go to your appointments. Seek separate authorizations for all follow-up appointments, treatment plan follow-up dates, plus any and all labs. CHS cannot pay for health care services without prior authorization.
- 5. Seek authorization within 72 hours of the start of emergency or urgent care. Elders or disabled clients have 30 days to notify our office in case of emergency care.
- Get copies of provider bills to our office. Without the bills, payments cannot be processed.
- 7. IF you have health care insurance(s), you must provide copies of your insurance Explanations of Benefits (EOBS) to our CHS staff. The EOB is the paper from the insurance company, which explains what they have paid and the unpaid balance. Without an EOB, payment will not be processed.

We have Contract Health Services staff people available to assist you. Please call with your questions.



EMERGENCY FUNDS

Recently, a representative from the Bureau of Indian Affairs visited our tribal offices to review the social services programs. According to the BIA, this fund is intended for members in the service area who experience emergencies caused by natural disasters, and is available after community resources are exhausted. Important changes based on the BIA visit 1) the budget has been lowered to \$3,500 for the year - drastic reduction 2) natural disaster is defined as flood, fire, tornado, etc. 3) rental payment assistance is not allowed under this fund. Effective October 1, 1998.

Since last year, more than 70% of the emergency fund have been authorized for rental payments, so this removal will result in a significant unmet need. After much discussion and investigation, it was found that the need for the emergency rental payment can be met through the Housing and Urban Development (HUD). Our goal is to make this transition without causing a hardship to tribal members; therefore, the EMER-GENCY RENTAL PAYMENT will be available October 1, 1998 but we need your patience while the details are finalized. Eligibility: circumstances must clearly constitute an emergency, must meet HUD income guidelines, reside in the service area, and need certification by the landlord and Tribal Social Services prior to authorization by the Housing Committee designee. Application and assistance is available in the Social Services Department. NOTE: because the funding source has changed, eligibility is contingent upon HUD regulations.

USDA Food Distribution Program on Indian Reservations (FDPIR)

Supplemental Food will be available at the Food Commodities Building beginning September 29th, ALL ENROLLED POKAGON BAND MEMBERS ARE ELIGIBLE, REGARDLESS OF INCOME OR COUNTY OF RESIDENCE. Available while supplies

Monthly food commodities are available to Native Americans who reside in the 10 county service area, in a city of 10,000 or less, and meet income guidelines set by the USDA (i.e.: monthly net income of less than \$792 for a household of 1).

Reminder: Dual participation in the FDPIR (commodi-

ties) and Food Stamp program is illegal and subject to losing benefits of both programs and/or fraud charges. The USDA is the funding source for both programs; therefore, collecting from both is considered "double dipping" and therefore discouraged. Commodities staff can help you to switch from one program to the other if you are interested in doing so.

LIHEAP

The Low Income Home Energy Assistance Program is available to help low income families pay for utility bills. Eligibility requirements: must be an enrolled Band member, residing in the 10 county service area, and provide proof of income (i.e.: monthly gross income less than \$1377 for household of 1). Available October 1998.

Injury Prevention

Fire extinguishers are still available in the Social Services Office. Tell your friends and family! We hope that you will never have to use them but, as they say, better safe than sorry! ALL ENROLLED POKAGON BAND MEMBERS ARE ELIGIBLE, REGARDLESS OF IN-COME OR COUNTY OF RESIDENCE.

JTPA

The JTPA program is a job-training program for individuals who may be economically disadvantaged, unemployed, or underemployed. Our JTPA program is specific to the Native American, Native Alaskan or Native Hawaiian population in the service delivery area. Interested? Please contact Tracy Wesaw, Job Training Specialist in the Social Services Department.

The Indian Child Welfare Act is a federal law passed by Congress in 1978 to protect Indian families and tribes from the removal of their children in state court proceedings and is designed to preserve Indian tribes and families. ICWA applies to cases in state court where a non-parent seeks to remove an Indian child from the home or control of its parents or Indian custodians. This typically occurs when Child Protective Services (CPS) files a petition in court charging the parents with neglecting, abusing, or abandoning their children. Foster care or adoptive placement is often sought in these situations. The Act also applies when the child is charged with wrongdoing, which would not be considered crimi-

nal if done by an adult, such as truancy. More next month...

YOU ARE INVITED: OCTOBER 21st at 7 p.m. (MI time) at the Elders Hall in Dowagiac - Michigan Indian Legal Services (MILS) will be presenting information on the Indian Child Welfare Act followed by the Michigan Indian Child Welfare Agency (MICWA) who will discuss what is involved in being a foster family and foster care licensing. If you are interested in helping our children or just curious about these topics, please plan to attend. Food and drinks will be provided. BUILDING STRONG FAMILIES

The BSF program offers training and information to parents about their newborn baby (through 3 years old), which covers the different developmental stages of your growing child, how to build self esteem, disciplinary techniques, and even immunizations. This is valuable information for new parents. Please contact social services outreach workers to schedule an appointment. Available October 1, 1998.

SOCIAL SERVICES POW WOW SURVEY

The social services and housing department shared a booth at the Kee-Boon-Mein-Kaa Pow Wow 9/5 and 9/ 6. Hundreds of helium balloons and stadium cups given away by the social services department, along with bumper stickers and pens from the housing department. In addition, individuals who completed the survey were entered into a raffle; three lucky Pokagon Band members won the 19-inch television and two CD players! The purpose of the giveaways was to attract people to the booth to get input for planning of the respective departments. More than 110 surveys were completed by residents in Michigan and Indiana. The three areas receiving the most votes as areas to 'expand, develop, or enhance' in the department were Indian Child Welfare, a Shelter (for homeless and/or battered women), and Elders Issues. Your input will shape the direction of our department. Thank you for your participation.

Rachel Daugherty asked Membership what issues do we want to put forward at the National Indian Council on Aging, August 22-26th. in North Dakota. Marge

Moody and Rachel are going to represent this group. Economic development is a major problem for us; but it's our problem.

Joe Winchester gave a report on the MIEA Conference, held in Mt. Pleasant, July 31st. & August lst. Joe reported that Clarence gave his Treasurer's report. Old business was made in reference to current By-Laws. There is some recommended changes to be made to benefit everyone concerned. Nominations were taken for those running for Office next October 6th. & 7th at Sault Ste. Marie. Nominations for Chair were Marge Moody, (declined) and Clinton Pelcher (accepted). A credit card will be primarily for traveling; such as airline tickets and hotels. Also items that don't have time to get through check processing.

Frank Person gave the Elders Logo Committee report in Fred Klemm's absence. The committee has four Elder logos. Frank will put them out for everyone to see. The committee doesn't want to make a decision on them yet.

Ann Zimmerman gave her Craft Committee report. Maybe we could make baskets or do beadwork on the same day as our social luncheons. We need a sign-up sheet for this 2 weeks before.

COMMUNITY DEVELOPMENT

Strategic Action Plan

The Community Development Department has begun work on a five year Strategic Action Plan being funded by ANA. The plan must be completed by April 1, 1999. As it pertains to the Pokagon Band and in its simplest form, a strategic action plan is an outline of the people's government, culture, health, and welfare in the past, present, and future. After assessing present conditions, goals will be established for the next five years and a plan to attain those goals will be formulated. For strategic planning to work, the process must be open and receive input and commitment from all groups within the Band such as general membership, elders, youth, cultural leaders, member employees, and governmental bodies such as Tribal Council, Elders Council, Youth Council, and all Pokagon Band Committees.

A Strategic Action Plan Committee (SAPC) must be formed to provide balanced viewpoints, while analyzing survey data and formulating goals and objectives to present to Tribal Council.

The importance of the SAPC cannot be overstated. It must be a body that can work together for the betterment of the Band by creating a living document to establish the Band's direction on specific goals over the next five years. The SAPC will be made up of Pokagon Members from all the groups listed above. The SAPC

members must be committed to attending two meetings a month for the next seven months and must be willing to promote strategic planning to the Pokagon Band Community. The Tribal Council is responsible for approving the membership of the SAPC.

The SAPC will have Co-Chairpersons chosen by the Committee. Thomas Morris will act as Committee Secretary to take meeting minutes and will provide a monthly article for the Band's newsletter along with a monthly report to the Tribal Council and Elders' Council.

Training for Strategic Planning will be attended by JoEllen Leith and Thomas Morris on October- 22 & 23. The information provided at this training will be passed along to the SAPC, Tribal Council, Elders Council, and all members who request it.


STAFF NEWS


The tribe has added a new employee in the accounting department. Diane Klapchuk of Dowagiac is the new accounting manager. She is located in the Administration offices.

EDUCATION REPORT



The Results from The Kee Boon Mein Kaa Pow-Wow language Questionnaire

The results are in! We had 46 questionnaires returned to us at the KeeBoon Mein Kaa (Kiboon Minké) Pow-wow (Nimediwen): 26 of those were completed by Pokagon band members; three by Huron Band members; two Citizen Nation members; two Potawatomi First Nation of Canada members. We also had two Little Traverse Bay Odawa members, two Grand Traverse Band members (Odawa), and eight non-tribal people return a questionnaire. The questions and their responses:

The most reoccurring idea was an immersion camp, a place where students can study the language intensely for a sustained period of time.

We also got a note of encouragement:

"This is a great and much needed project. Learning our language helps to make us a true tribe."

We distributed 75 copies of each book, Ngod Gizhget and Giwani Kazho, with its accompanying cassette. In addition to distributing language materials to Pokagon Band membership, we also worked a resource exchange with other Native communities doing the same work. We exchanged information with Isadore Toulouse, an Ojibwé, working with his language in Toronto Canada; George Strack, a Miami working on his language in Oklahoma. And Susan Campbell, Citizens Nation Potawatomi, who teaches a Potawatomi language class in Seattle. With the exception of these individuals, the entire bulk of the material went straight to the membership.

Congratulations to Thomas Morris of North Liberty, our winner of the Language Program basket raffle!

In this month's newsletter, you'll see that we are circulating the questionnaire again. Please take the time to complete it and mail it to us. We need your input! Each completed questionnaire will be collected, and another raffle will take place November 20, 1998 at Elders Hall. The prize is a six-inch German silver broach valued at \$120. You need not be present to win and all entries are due November 19, 1998. Enter early!


