In our Health Services we can help you learn more bout how to eat healthy with education through Nancy Appel, our Registered Dietician. We can also check your cholesterol and lipid panel to warn you of dangerous levels that make you high risks for Heart Disease. So start this year out right by calling us at the Pokagon Indian Health Services and set an appointment with one of our health staff to have your lipid Panel (Cholesterol, HDL, LDL, Triglycerides, Glucose) completed or phone our Dietician now to learn how you can improve your diet to help combat this disease in our community. Please call now at 1-888-440-1234 or 782-4141.

Do you know your blood cholesterol/lipid or hemoglobin level?

If not, maybe we can help you. Here at the Pokagon Potawatomi Health Services, we are equipped to measure all these levels and more. With just a simple finger stick, we can monitor your total cholesterol including HDL (good), LDL (bad), triglycerides, total cholesterol/HDL ratio, your glucose (blood sugar), and your hemoglobin (detects anemia or low iron). Knowing these levels can help us to help you understand and learn how to maintain and improve your health.

These are free services for our Pokagon Members. Call and ask for one of our nurses to set up an appointment. 

SAPC UPDATE

January 12, 2001

The three SAPC meetings scheduled since November 15th were canceled due to extreme winter weather and family health concerns for key participants. A lunch meeting with the co-chairpersons and Kenneth Antisdel was held Thursday, January 11th, to discuss scheduling SAPC meetings on a permanent basis. It was agreed to schedule future meetings on the first and third Wednesdays of each month at the Behavioral Health Office at 6 p.m. The permanent schedule should help to give the SAPC more momentum in dealing with tribal issues concerning planning. The SAPC is working on land and resource use recommendations to Tribal Council, reviewing the application for a \$5,000 grant from the First Nations Development Institute's Eagle Staff Fund, and discussion of the upcoming economic development conference at the Mississippi Choctaw in late March.

HISTORIC PRESERVATION SURVEY

Dear Tribal Citizens;

The Traditions/Repatriation Committee was established to deal with the complex political and social issues that arise from Federal Legislation that regulates and safeguards cultural and natural resources found within aboriginal territory of the tribe.

The National Historic Preservation Act of 1966 (NHPA) requires federal agencies to take into consideration the impacts a project will have on the environment, including historic properties. Through this Act, tribes have the ability to protect properties that are significant both historically and culturally. NHPA provides funding for research and documentation of such properties, along with Federal protection once placed on the Federal Register of Historic Places.

Recently, the Pokagon Band of Potawatomi Indians received funding, through a grant from the National Parks Service (NPS), to create a long-term plan for Historic Preservation. To do this the committee needs input from the membership on what they feel is important both historically and culturally. This can include a wide range of different topics, as you saw in the survey mailed to each tribal citizen's home.

What was so important about another survey? This survey will guide the future of our Tribe by setting the goals for collecting the history of our ancestors. It will allow the Tribe to exert its Sovereignty by utilizing this Federal Law to protect our historic sites, culture, civil rights, freedom of religion, and our environment.

The survey was set up and mailed to each of our citizens' sixteen years and older to determine which topics our citizens feel have priority. As the surveys were returned, each was dated and numbered and then logged onto a spreadsheet to tally the responses. In order to rank the topics in order of importance to the tribal citizens, the responses were awarded a numerical value as follows:

EXTREMELY IMPORTANT --- 4 PTS. VERY IMPORTANT ---- 3 PTS.

NEUTRAL / NO OPINION ----- 2 PTS.

NOT VERY IMPORTANT ---- 1 PTS. NOT AT ALL IMPORTANT ---- 0 PTS.

NO RESPONSE ----- 0 PTS.

The score used for ranking each topic was arrived at by adding the total numerical values for each topic and then dividing that total by the number of surveys returned. The supporting demographic charts show where the survey responses came from and the number of responses by the various age groups.

Our history and our people are precious, we need to preserve both for the generations ahead to see the accomplishments and feel the pride that the Pokagon Band of Potawatomi has had for generations.



Rate of pay will be determined by the position being filled and meeting minimum requirements of that position.

Temporary Employees will be subject to applicable rules of the Pokagon Band Employee Handbook.

This is an excellent opportunity for our Membership to occasionally supplement their income, gain experience while aiding us to continue smooth delivery of our services.







Do you know what your Hgb A1c is? This is a quick lab test that shows an average of what your blood sugar levels have been for the last three or four months. It will help you know how to better control your Diabetes. The Pokagon Band Housing Authority can assist households experiencing temporary mortgage and rental-based housing crises through the Emergency Mortgage and Rental Payment Assistance Program. In order to be considered for assistance, an applicant must submit the following items:

- > A completed Pokagon Band Housing Authority Emergency Mortgage and Rental Payment Assistance Program application;
- Certification of a handicap or disability from two different sources (if applicable);
- > Proof of Tribal enrollment (if applicable);
- > Verification of status as the current or prospective holder of a lease or a mortgage for a property for which you are unable to pay a pending rental or mortgage payment; and
- > Proof of income in the form of an income tax return. If you do not have this form, you must sign and notarize a statement indicating the reason why you did not file a tax return. The Housing Authority cannot accept wage stubs or W-2 statements as proof of income.

In order to receive program assistance, an applicant must:

- > Meet the Department of Housing and Urban Development's definition of low-income (these figures vary by county and by household size -- please consult the Housing Authority regarding particular situations);
- Live in a situation that meets the definition of emergency outlined in the program's policy, including but not limited to situations involving involuntary displacement, substandard housing, or paying more than fifty percent (50%) of income toward a rent or mortgage payment;

- Live in a situation in which you are verifiably a lease or mortgage holder (persons who pay rent to close relatives are ineligible for assistance unless their arrest record or similar circumstances precludes any other type of living arrangement);

In order to receive rehabilitative assistance, an applicant must:

- Meet the Department of Housing and Urban Development's definition of low-income. These figures vary by county and by household size; please consult the Housing Authority regarding particular situations;
- ➤ Live in a substandard house as that term is defined in Title 25, Section 256 of the Code of Federal Regulations. Overcrowding, inadequate plumbing, heating, and electrical wiring typically characterize a substandard house;
- > Live in the Pokagon Band's ten county housing service area;
- > Live in a home that will pass an environmental inspection;

> Own the home proposed for repair and rehabilitation;

- > Carry flood insurance if the home is located in a flood-prone area; and
- Submit a completed application (including all supporting documentation) to the Pokagon Band Housing Authority, 714 N. Front Street, Dowagiac, Michigan, 49047 by 5:00 pm on Friday, March 30, 2001.

After March 30, the Board of Commissioners will review, rate, and rank all applicants, affixing priority consideration to the following categories:

- ➤ The Handicapped

POKAGON BAND HOUSING AUTHORITY HOME REHABILITATION AND PRESERVATION PROJECT funded by the UNITED STATES DEPARTMENT OF AGRICULTURE (USDA)

The Pokagon Band Housing Authority is administering a grant funded by the United States Department of Agriculture (USDA). This program differs from the Pokagon Band Housing Authority's Home Repair and Rehabilitation Program in three ways:

The maximum allowable expense per home is \$2,500;

- Proof of income in the form of an income tax return. If you do not have this form, you must sign and notarize a statement indicating the reason why you did not file a tax return. The Housing Authority cannot accept wage stubs or W-2 statements as proof of income.

In order to receive rehabilitative assistance, an applicant must:

- Meet the Department of Housing and Urban Development's definition of low-income. These figures vary by county and by household size; please consult the Housing Authority regarding particular situations;

- ➤ Live in a home that will pass an environmental inspection;
- > Own the home proposed for repair and rehabilitation;
- > Carry flood insurance if the home is located in a flood-prone area; and

- Four Wisemen -

(Excerpted from "Four Blocks, Twelve Push-ups"; used with the author's permission)

Indians always do things in fours. Well, I can't speak for all Indians doing all things; I can only recall what I was taught and what I saw reflected in the behavior of my kindred. And, the peoples' teachings are carried by the four winds to the four corners of the earth. Their words blow like leaves until, eventually, they are swept over the furthest of the four corners of the earth, and the only thing the Indian people can do is stand on the rim, watching those words cascade into the deep black and longing for the days before the whites turned the earthly plane sideways and saw it was actually a hoop. We Indian people seized that hoop, wove a web inside it, and told our children - and anyone else who cared to listen - that it would catch their dreams. I always turned that hoop in the palm of my hand until the luster of the metal ring, leather binding, sinew webbing, and glass beads intermingled and spun with the brilliance of a kaleidoscope - all the time wondering what sort of filter caught our words.

"Indian people always do things in fours," Grandpa Leonard was adamant

about that point of Indian culture.

When my brother, Vincent, was an awkwardly overweight, church-going schoolboy (all these and lesser-included phases equally short-lived), he cried for days before begrudgingly accepting the unglamorized, peripherealized role of a shepherd in the Christmas Pageant at the Ponca Indian Methodist Church.

Well, what did you expect to be, grandson?" Grandpa Leonard looked down as he loaded his pipe, deliberately avoiding a look at the boy's tear-

"A wiseman," Vincent choked out between gasps and sobs.

"Ahhh, a wiseman," the old man nodded approvingly. Grandpa Leonard most probably never had entered a church in his life, but I'm sure he must have pictured a wiseman as someone akin to an Indian medicine man.

'And who's kids were picked to be wisemen?" Grandpa Leonard's ears were always attuned to the political workings of the reservation. "I could probably tell you their last names before you remember them.i"

'Cornell Jacobs ... Snook Elliot ... ummm," Vincent groped for the name, "oh ya --- John Gibson."

"Who else?," Grandpa waited for more names to add to his swelling, inevitable diatribe that all jobs and benefits on the reservation were politically based and executed.

'Grannnnndpa," Vincent prepared to question his elder's grasp of the world, "there are only three wisemen."

"Three wisemen? Just three?" Grandpa was so invigorated by this piece of information that he looked up from his pipe and squared his eyes with the

The next night, as the motley crew of Indian children assembled in the community hall - adorned in the best possible recreations of nativity figures that the Salvation Army could supply - Grandpa Leonard waded through with his hand firmly resting on the shoulder of what must have looked to the others as a very ostentatiously dressed shepherd.

"Oh, my goodness," one of the non-Indian missionaries exclaimed as she spied the incongruent shepherd, "is this your shepherd's costume?"

"It's regalia, not a costume." Grandpa Leonard spent his life being so enraged over non-Indian people who referred to his traditional Indian clothes as a costume, that he now uttered those words in a reflex reaction, even though, on that night, Vincent really wore a costume. "And he's a medicine man."

"Wiseman," the little boy whispered as he turned and looked upward at his Grandfather.

"Like I said, he's a wiseman." Grandpa Leonard pushed Vincent toward the flustered woman who was now looking right and left for an Indian church leader who could diffuse the situation.

But there are only three wisemen and Vincent knows he's to be a shepherd tonight." Finding no nearby Indian ally, the woman pleaded her own case.

'No, you're wrong." When all else failed, Grandpa invoked his status as an elder knowledgeable in all things Indian. He swept his hands through the air and postured in a way familiar to all who knew him. He spoke slowly and declaratively. "Indians only do things in fours," he told the woman who, starved by her own quest for Indian knowledge, now listened intently. "When God works in Indian country, he brings four wisemen."

And, Grandpa Leonard must have been right because the Ponca people who attended the pageant that night - even those people so steeped in Christianity and so far removed from Indian culture that they wouldn't know a moccasin from a cowboy boot - nodded vigorously and even called out in approval as the fourth, somewhat bedraggled wiseman jointed the processional on stage.

SMOKE ALARMS DO NOT WORK IN ABOUT 16 MILLION HOMES

The U.S. Consumers Product Safety Commission (CPSC) suggests consumers test their smoke alarms to ensure that they work properly. The start and end of daylight savings time are good reminders.

- Fire is the second leading cause of unintentional death in the home. Each year nearly 3,200 people die in residential fires. There are more than 390,000 residential fires serious enough to be reported to fire departments.
- About 90 percent of U.S. households have smoke alarms installed.
- A CPSC survey found that smoke alarms in 20% of those households - about 16 million - were not working because the battery was dead or missing.
- Batteries should be replaced at least once a year or when they make a "chirping" sound.
- Long-life smoke alarms with 10-year batteries should be tested monthly.
- CPSC recommends consumers place a smoke alarm that meets the requirement of Underwriter Laboratories (UL) standard on each level of multi-story homes outside sleeping areas and inside bedrooms.

Without in any way limiting the generality of the foregoing, the Band expressly authorizes any governmental authorities who have the right and duty under applicable law to take any action authorized or ordered by any such court to give effect to any judgment entered; provided, however, that in no instance shall any enforcement of any kind whatsoever be allowed against any assets of the Band other than the limited assets of the band specified in Section 11.d,(i) of the Letter Agreement. The Band appoints the Chairman of the Pokagon Council and the Secretary of the Pokagon Council as its agents for service of all process under or relating to this Agreement. The Band agrees that service in hand or by certified mail return receipt requested shell be effective for all purposes under ice in hand or by certified mail, return receipt requested, shall be effective for all purposes under or relating to this Agreement if served on such agents.

That the Letter Agreement hereby authorized shall be interpreted and applied in accordance with the federal law of the United States and the law of the State of Michigan.

That it is the intent of this Council that this Resolution, and the actions taken by tribal officials pursuant to this Resolution, are authorized under applicable tribal law and that the Resolution and such actions taken hereunder, including execution of and performance under the Letter Agreement, be binding upon the Band in the future, whether or not a tribal constitution is adopted under 25 U.S.C. ss 1300j-4(a) or the Indian Reorganization Act as amended.

That this Resolution take effect immediately.

Section 1

Who May Propose By-Laws Changes

Section 2

Requirements for Proposing Changes.

Except as provided in Section 4 and 5 below, amendments to the Elders Council By-Laws may be made only at the Annual Meeting of the Elders Council. Before amendments may be voted on at the Annual Meeting, the Officers must:

In order to protect the welfare, peace or safety of the Elders Council and Membership, the Elders Council By-Laws may be changed at any duly called open meeting of the Elders Council if:

(A) The proposed change is presented in writing:

(B) A majority of the Elders Council Membership present at any such meeting agree to vote on the proposed By-Laws change; and

(C) Three-fourths (3/4) of the Elders Council Membership present at any such meeting further vote affirmatively to accept the proposed change.

Section 5. Changes in Pokagon Band Law.

AS stated in Section 14 (A) of the Elders Council Ordinance, the Elders Councils
By-Laws may not violate Pokagon Band Law. Any change to the By-Laws, therefore, required by amendment to the Elders Council Ordinance or by other provisions
of Band Law shall take effect immediately and without the requirements established in Section 1 through 4 of this article






Watervliet Middle School "Student of the Week"
